Subject: Ban on transfers- instructions thereof.

Sir/Madam,

I am directed to invite your attention to this Department's letter of even number dated 22-03-2022 on the subject cited above vide which a complete ban has been imposed on general transfers of employees. It was also conveyed that the ban on general transfers shall continue in force and transfer only in the circumstances may be ordered with the approval of competent authority i.e. Hon'ble Chief Minister, H.P, as provided in Para 8 of CGP-2013. The transfers orders being issued in other eventualities are in violation of instructions ibid.

2. It has now been decided by the Government to impose complete ban on transfers. It is, therefore, requested that only such proposal of transfers of government employees may be processed and implemented, which are strictly in consonance of circumstances specifically provided under Para 8 of the Comprehensive Guiding Principles-2013, circulated vide G.M. No. Per(AP-B)E(3)-17/2012 dated 10-07-2013 and having only the approval of Hon'ble Chief Minister.

2. These instructions may be brought to the notice of all concerned for strict compliance.
