ORDER

Sh. Daljeet Singh, TGT (Arts) has filed CWP No. 2216/2022- before the Hon'ble High Court regarding transfer from GMS Barchhwar u/c GSSS Nabahi, Distt.Mandi to GSSS Doghari, Distt.Mandi. The case was listed on 28.03.2022, when the same has been disposed of with the following directions:-

"The respondent No.2 to take a decision on the representation of petitioner as expeditiously as possible preferably within two weeks from today.

In compliance to the order passed by the Hon'ble High Court the petitioner has submitted his representation vide which he has requested that due to adverse family circumstances he may kindly be adjusted in GSSS Tikkri Sidhwani, Distt. Mandi/ GMS Duhak u/c GHS Kallar, Distt.Bilapsur, against longer stayee.

On the perusal of record, it is found that Sh.Daljeet Singh, TGT(Arts) was transferred from GMS Barchhwar u/c GSSS Nabahi, Distt.Mandi to GSSS Doghari, Distt. Mandi, on vice versa basis , after completion of normal tenure with the prior approval of the competent authority. Now, Sh. Daljeet Singh, TGT(Arts) has already joined at GSSS Doghari, Distt. Mandi on 25.04.2022.

Keeping in view of the above facts and circumstances, the representation of Sh. Daljeet Singh, TGT (Arts) cannot be considered, as he has joined at GSSS Doghari, Distt. Mandi , where he was transferred. Accordingly, his representations is decided.

ORDER

Smt. Neelam Kumari, TGT (Arts) has filed CWP No. 2184/2022- before the Hon'ble High Court regarding transfer from GMS Ghumarli u/c GSSS Bair, Distt.Hamirpur to GHS Phakloh, Distt.Kangra. The case was listed on 08.04.2022, when the same has been disposed of with the following directions:-

"Petitioner is at liberty to make representation to respondent No.2 on or before 11.04.2022 and in case such representation is preferred by petitioner, the same shall be considered and decided by respondent No.2, within a week thereafter and till then petitioner shall not be compelled to join her next place of posting. It is made clear that it shall not operate as a stay against transfer of respondent No.3. The petition is disposed of in accordance terms alongwith pending application(s), if any.

In compliance to the order passed by the Hon'ble High Court the petitioner has submitted her representation vide which she has requested that she may kindly be adjusted in GHS Plah Brahamna/ GSSS Basaral, Distt.Hamirpur/ GSSS Saroh, Distt.Una.

On the perusal of record, it is found that Smt. Neelam Kumari, TGT(Arts) was transferred from GMS Ghumarli u/c GSSS Biar, Distt.Hamirpur to GHS Phakloh, Distt.Kangra on vice versa basis , after completion of normal tenure with the prior approval of the competent authority. Now, Smt. Neelam Kumari, TGT(Arts) has already joined at GHS Phakloh, Distt. Kangra on 11.04.2022.

Keeping in view of the above facts and circumstances, the representation of Smt. Neelam Kumari, TGT (Arts) received on 19.04.2022, cannot be considered, as she has joined at GHS Phakloh, Distt. Kangra, where she was transferred. Accordingly, her representations is decided.
