Shri Anil Kumar, TGT (NM) preferred CWP No. 1074/2022 titled as Anil Kumar, TGT(NM) Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GMS Chask u/c GSSS Sechunala, Tehsil Killar(Pangi) District Chamba(hard area) to the station of his choice in soft area. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 2.3.2022 when the Hon'ble High Court has passed the following orders:-

" 2. As per pleadings in the petition, the petitioner gave his joining as TGT on contract basis in Government Middle School Chask, District Chamba on 14.3.2019. He will complete three years period on 14.03.2022. In view of the facts pointed out in the writ petition, we dispose of instant writ petition by permitting the petitioner to file a representation for his transfer within a period of three weeks from today, whereafter the respondents shall decide the representation and pass appropriate order in accordance with law and applicable transfer policy within a further period of three months thereafter. The copy of the decision, so arrived at, be supplied to the petitioner. Pending applications, if any, also stand disosed of."

In the compliance of the aforesaid orders passed by the Hon'ble High Court, the petitioner was called for personal hearing through video conference on 26.4.2022 and he attended the same. At the time of hearing he stated that he has completed three years stay in hard/sub-cadre area and entitled to transfer for the station of his choice as per policy. He further requested that he may be adjusted at the station of his choice in District Kangra.

From perusal of record, it has been found that the petitioner is working in GMS Chask u/c GSSS Sechunala District Chamba since 14.3.2019 and has completed more than three years stay at his present place of posting and entitled for his transfer to the station of his choice as per policy. One Shri Rajesh Kumar, TGT(NM) working in GHS Katholi u/c GSSS Nagrota Surian District Kangra since 20.9.2017 and has completed more than three years stay there. The petitioner has given willingness for his transfer to the aforesaid school against longer stay. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetically, and he is hereby transferred without TTA from GMS Chask u/c GSSS Sechunala (Pangi) District Chamba to GHS Katholi u/c GSSS Nagrota Surian District Kangra vice Shri Rajesh Kumar, TGT(NM) & vice-versa, with TTA/JT to Shri Rajesh Kumar, TGT(NM). The representation of the petitioner is disposed of accordingly.
