Smt. Kamlesh Kumari, TGT (NM) preferred CWP No. 2910/2021 titled as Kamlesh Kumari, TGT(NM) Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GMS Matuli u/c GHS Baila District Solan to District Hamirpur. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 23.8.2021 when the Hon'ble High Court has passed the following orders:-

"After arguing the matter for some time, learned counsel for the petitioner submits that the petitioner may be permitted to file a representation to respondent No. 1, placing her grievance before the said respondent. Hes submission is placed on record. Hence, a week's time is granted to the petitioner to submit her representation to respondent No. 1 and a week's time thereafter to consider the same by the said respondent, in accordance with law. Till then, the interim order dated 25.6.2021, shall continue."

In the compliance of the aforesaid orders passed by the Hon'ble High Court, the petitioner has submitted her representation in this office on 1.9.2021 vide which she has requested that she was transferred to GSSS Balduhak District Hamirpur against vacancy vide order dated 29th April, 2021 but one Smt. Alka Dalwan,TGT(NM) was joined there before her. She retuned back and joined her previous place of posting, Now, she has again requested vide her representation dated 22.3.2022 that she may be adjusted in Hamirpur District against vacancy being caused due to promotion of the present incumbent due to her adverse family circumstances.

From perusal of record, it has been found that the petitioner is working in GMS Matuli u/c GHS Baila District Solan since Dec,2020 and has not completed three years stay at her present place of posting. The petitioner was transferred from GMS Matuli u/c GHS Baila District Solan to GSSS Balduhak District Hamirpur against vacancy in condonation of short stay, with the prior approval of competent authority but these orders could not be implemented as another TGT(NM) joined there. Therefore, keeping in view of the above fact and circumstances the representation of the petitioner is considered sympathically and she is hereby transferred without TTA/JT & in condonation of short stay from GMS Matuli u/c GHS Baila District Solan to GSSS Sasan District Hamirpur against vacancy being cause due to promotion of the present incumbent as Lecturer in near future, on her own request. These orders will be implemented after the relieving of the present incumbent on promotion. The representation of the petitioner is disposed of accordingly.
