In the matter of: CWP No: 8048/2021-titled as Ravinder Kumar, TGT (Arts) Vs. State of Himachal Pradesh (Regarding Transfer)

ORDER

Sh. Ravinder Kumar, TGT(Arts) has filed CWP No. 8048/2021- before the Hon'ble High Court regarding transfer from GMS Nal u/c GSSS Tanbol, Distt. Bilaspur. The case was listed on 22.12.2021, when the same has been disposed of with the following directions:-

Accordingly, without going into merits of the case, we deem it proper to direct the respondents to consider and decide the case of the petitioner under para 5.4 of the comprehensive guiding principles-2013 (supra) within a period of three weeks from today. Ordered accordingly.

The instant petition is disposed of, in the aforesaid terms, so also the pending application(s), if any.

In pursuance to the orders passed by the Hon'ble High Court of Himachal Pradesh, the petitioner i.e Sh. Ravinder Kumar, TGT (Arts) was called for personal hearing and appeared before the undersigned on dated 01.02.2022. He requested that due to adverse family circumstances and couple case he may kindly be transferred from GMS Nal u/c GSSS Tanbol (Bilaspur) to GHS Majhiar (HMR)/ GSSS Majheen (Kangra)/ GHS Maharal/ GSSS Hathol/ GHS Mann/ Amlehar/Amroh/Putrial/Dandroo/Didwin/Sasan/Rail, Distt. Hamirpur, against vacancy, being caused due to promotion of the present incumbent,.

On the perusal of record, it is found that Sh. Ravinder Kumar, TGT (Arts) is working in GMS Nal u/c GSSS Tanbol (BLP) since 03.10.2017 and has completed his normal tenure at the present place of posting. The petitioner stated in his representation that his wife is serving as Language teacher in GSSS Muhal (KGR) which belongs to district cadre and his daughters are studying in Distt.Hamirpur. As per para 5.4 of the comprehensive Guiding Principles-2013 "***In case wife and husband both are working under the State Government efforts be made to post them at one place of near places as far as possible subject to vacancy.***"

In view of facts stated above, representation of petitioner i.e Sh. Ravinder Kumar, TGT(Arts) is considered sympathetically and he is hereby transferred from GMS Nal u/c GSSS Tanbol, Distt.Bilaspur to GSSS Dandroo, Distt. Hamirpur, against vacancy, being caused due to promotion of the present incumbent as Lecturer in near future, on his own request. These orders will be implemented after the relieving of the present incumbent on promotion. The representation of the petitioner is disposed of accordingly.
