Una against longer stayee or promotion of present incumbent.

Chamba (which fall under hard /Tribal area) , has completed his normal tenure at present place of posting. Keeping in view of the position stated above the representation of the petitioner is considered sympathetically and he is hereby transferred from GHS Chari u/c GSSS Mehla Dsitt. Chamba to GSSS Lathial Distt. Kangra , without TTA/JT vice Sh. Vijay Singh,TGT(Med), with TTA/JT. The representation of the petitioner is disposed of accordingly.
