ORDER

Sh. Kushal Kumar, TGT (Arts) has filed CWP No. 2738/2022- before the Hon'ble High Court of H.P. regarding transfer from GSSS Rai, Distt. Chamba. The case was listed on 05.05.2022, when the same has been disposed of with the following directions:-

"In case the petitioner moves a fresh representation to the respondents, in terms of the transfer policy, dated 10th July, 2013, within a week from today, then respondents shall dispose of the same within two weeks of the receipt of the representation, in accordance with law. Pending application (s), if any, also stand disposed of."

In compliance to the order passed by the Hon'ble High Court the petitioner has submitted his representation vide which he has requested that he may kindly be transferred from GSSS Rai, Distt.Chamba to GSSS Golwan/ GSSS Barot/ GSSS Rehan (Boys)/ GHS Larth/ GMS Cheer u/c GSSS Makroli, Distt.Kangra.

From perusal of record, it has been found that the petitioner is working in GSSS Rai, Distt. Chamba (Tribal area) since 04.12.2019 and has not completed his normal tenure at the present place of posting. As per provisions contained in the transfer policy 2013 para 16 (16.1) "the normal tenure for transfers in Difficult/Tribal/Hard/Most Difficult areas will be three years i.e. two winters and three summers.

Keeping in view of the position stated above, the representation of Sh. Kushal Kumar, TGT (Arts) cannot be considered, as he has not completed his normal tenure at the present place of posting. The representation of the petitioner is disposed of accordingly.
