Smt. Kumari Shavnam, TGT (NM) preferred CWP No. 2081/2022 titled as Ku. Shavnam, TGT(NM) Vs. State of H.P. before the Hon'ble High Court of H.P. regarding her transfer from GSSS Gehra District Chamba to her home District i.e. Kangra District. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 06.4.2022 when the Hon'ble High Court has passed the following orders:-

"4. Accordingly, without adverting to the merit of the case, this writ petition is disposed of with a direction that in case the petitioner moves a fresh representation to the respondents, in terms of the transfer policy, dated 10th July, 2013, within a week from today, then respondents shall dispose of the same within two weeks of the receipt of the representation, in accordance with law.

Pending application(s), if any, also stand disposed of."

In the compliance of the aforesaid orders passed by the Hon'ble High Court, the petitioner has submitted her representation in this office on 22.4.2022 vide which she has stated that she has completed three years stay in hard/sub-cadre area and is suffering from serious health problem. She further requested that she may be adjusted in her home District Kangra in the school of her choice.

From perusal of record, it has been found that the petitioner is working in GSSS Gehra District Chamba(sub-cadre area) since 30.3.2019 and has completed more than three years stay at her present place of posting. She has given five stations of her choice in District Kangra but no longer stayee is working there as per information received from Deputy Director of Elementary Education, Kangra at Dharamshala. However, petitioner has given her request for adjustment at GSSS Bhoda District Kangra against vacancy being caused due to promotion of present incumbent in near future. Keeping in view the above facts and circumstances the representation of the petitioner is considered sympathetically and she is hereby transferred on her own request from GSSS Gehra District Chamba to Govt. Sr. Sec. School Bhoda, District Kangra against vacancy being caused due to promotion of present incumbent in near future. These orders will be implemented after the relieving of the present incumbent on promotion. The representation of the petitioner is disposed of accordingly.
