The Petitioner Ms.Reena Dhiman ,filed CWP No. 1968/2022 titled as Ms.Reena Dhiman, TGT (Med) versus State of H.P. before the Hon'ble High Court of H.P. regarding her transfer from GSSS Kunra Distt. As per direction of the Hon'ble High Court the petitioner was called for personel hearing on dated 11-04-2022, she represented to this office regarding her representation that she may be adjusted in GHS Jhunga Devi, GHS Thandol, GSSS Lahat, GSSS Andretta, GSSS Makol against longer stayee and GSSS Sujanpur Tihra on promotion of presnt incumbent(TGT to PGT)

From the perusal of the record, it reveals that Ms. Reena Dhiman ,TGT(Med), has been working in GSSS Kunra Distt. Chamba since 19th March,2019 (which fall under sub cadre area) and has completed her normal tenure at present place of posting. Hence keeping in view the family circumstances the petitioner is hereby transferred from GSSS Kunra Distt. Chamba to GHS Jhunga Devi District Kangra without TTA/JT vice Smt.Sunita, TGT(Med), with TTA/JT. The representation of the petitioner is disposed of accordingly.
