ORDER

In the matter :

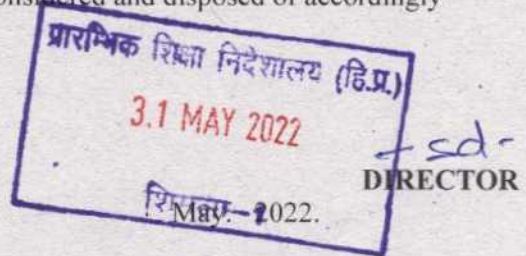
CWP No.2850/2022 titled as Sumana Devi,TGT(Med) Vs State of H.P. & others.

The Petitioner Smt. Sumana Devi,TGT, (Med), filed CWP No. 2850/2022 titled as Smt. Sumana Devi,TGT(Med), versus State of H.P. before the Hon'ble High Court of H.P. regarding her transfer from GSSS Somanachani Distt. Mandi (which fall under hard area) to her choice of station after the completion of required tenure as per policy. The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 09th May,2022, when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions/ order:-

" Accordingly,without adverting to the merits of the case, this writ petition is disposed of with a direction to the respondents to dispose of the representation 20th April,2022 (Annexure P-3), moved by the petitioner expeditiously, in accordance with law,preferably within two weeks from the date of receipt of the copy of this order."

As per direction of the Hon'ble High Court the petitioner submitted her representation on 21-05-2022, in which she has requested that she may be adjusted in GSSS Patta,GSSS Dhamrol,GSSS Hamirpur(G),GSSS Bajrol Dsitt. Hamirpur or GHS Yora(J/Nagar) (vacancy due to school upgradation),GSSS Longni, GGSSS Sarkaghat, GSSS Rakoh Distt. Mandi due to promotion of present incumbent TGT to PGT.

On the perusal of record, it is found that Smt. Sumna Devi,TGT(Med), working in GSSS Somanachani Dsitt. Mandi (which fall under hard area) since 13th March 2019, has completed her normal tenure of three years. Keeping in view the position stated above the petitioner is hereby transferred from GSSS Somanachani Distt. Mandi to GSSS Rakoh Distt.Mandi against vacancy being casued due to promotion of present incumbent. These orders will be implemented after the relieving of incumbent who is going to be promoted. With these observations the representation of the petitioner is considered and disposed of accordingly
