In the matter of: CWP No. 1099/2022 titled as Anil Kumar Vs. State of H.P. & Others.

Shri Anil Kumar, TGT (NM) preferred CWP No. 1099/2022 titled as Anil Kumar, TGT(NM) Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GSSS Karyuni (Pangi) District Chamba( hard area) to the station of his choice in soft area. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 16.3.2022 when the Hon'ble High Court has passed the following orders:-

" 3. Having regard to the limited prayer made in the writ petition and without going into the merits of the case, we dispose of the writ petition by directing respondent No. 2 to decide the aforesaid representations made by the petitioner, in accordance with law, within a period of four weeks from the date of submission of the copy of this order before respondent No. 2. Pending miscellaneous applications, if any, shall also stand disposed of accordingly."

In the compliance of the aforesaid orders passed by the Hon'ble High Court, the petitioner was called for personal hearing through video conference on 26.4.2022 and he attended the same. At the time of hearing he stated that he has completed three years stay in hard/sub-cadre area and entitled to transfer for the station of his choice as per policy. He further requested that he may be adjusted at the station of his choice in District Una/Kangra.

From perusal of record, it has been found that the petitioner is working in GSSS Karyuni District Chamba since 19.3.2019 and has completed more than three years stay at his present place of posting and entitled for his transfer to the station of his choice as per policy. One Shri Anil Kumar, TGT(NM) working in GSSS Chintpurani District Una since 13.9.2018 and has completed more than three years stay there. The petitioner has given willingness for his transfer to the aforesaid school against longer stay. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetically, and he is hereby transferred without TTA from GSSS Karyuni (Pangi) District Chamba to GSSS Chintpurani District Una vice Shri Anil Kumar, TGT(NM) & vice-versa, with TTA/JT to Shri Anil Kumar, TGT(NM). The representation of the petitioner is disposed of accordingly.
