The Petitioner Smt. Shilpa Devi,TGT(Med),filed CWP No. 3153/2022 titled as Shilpa Devi,TGT (Med) versus State of H.P. before the Hon'ble High Court of H.P. regarding her transfer from GSSS Sunara (B.Mehla) Distt.Chamba (which fall under hard /Tribal area) to his choice of station after the completion of required tenure as per policy. The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 20<sup>th</sup> May.2022, when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions/ order:-

"Accodingly, without adverting to the merits of the case ,this writ petition is disposed of with a direction that in case the petitioner moves a fresh representation to the respondent in terms of the transfer policy dated 10<sup>th</sup> July,2013, within a week from today, then respondents shall dispose of the same within two weeks from the receipt of the representation,in accordance with law"

As per direction of the Hon'ble High Court the petitioner submitted her representation on 27<sup>th</sup> May.2022, in which she has requested that she may be adjusted in GSSS Harsar, GHS Kardial,GHS Tahallian,GHS Katholi Distt. Kangra and GSSS Samote Distt. Chamba against longer stayee or vacancy. The petitioner has further stated that her parents are suffering from various old age ailments and no one in the family to look after them.

On the perusal of record, it is found that Smt. Shilpa Devi,TGT(Med), working in GSSS Sunara (Mehla) Distt.Chamba (which fall under hard area) since 08<sup>th</sup> March 2019, has completed her normal tenure of three years. Keeping in view of the position stated above the representation of the petitioner is considered sympathetically and she is hereby transferred from-from GSSS Sunara (B.Mehla) Distt. Chamba to GSSS Pargour Distt. Kangra against vacancy without TTA/JT. With these observations the representation of the petitioner is considered and disposed of accordingly.
