Whereas, Sh. Sanjay Kumar Rehalia, TGT (NM) preferred CWP No. 3696/2022 titled as Sanjay Kumar Rehalia Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GSSS Ganed Distt. Chamba to his native place. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 14.06.2022 when the Hon'ble High Court has passed the following orders:-

*"3. Accordingly, we deem it proper to dispose of this petition by directing the respondents to consider and decide the case of the petitioner and thereafter issue consequential order of transfer of the petitioner to one of the aforesaid stations of his choice. This exercise be completed within four weeks.*

*4. The petition stands disposed of in the aforesaid terms, so also pending applications, if any.*

*For compliance to come up 12.7.2022."*

From perusal of record, it has been found that the petitioner has been working in GSSS Ganed District Chamba (sub-cadre area) since 6.3.2019 and has completed more than three years stay at his present place of posting. 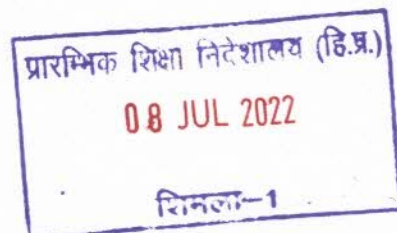

Whereas, Sh. Sunil Kumar, TGT (NM) preferred CWP No. 2892/2022 titled as Sunil Kumar Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GMS Thaloga u/c GSSS Telka Distt. Chamba to his native place. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 10.05.2022 when the Hon'ble High Court has passed the following orders:-

*"5. In such circumstances, we deem it proper to dispose of this petition by directing the respondents concerned to consider the case of the petitioner sympathetically, taking into consideration the fact that daughter of the petitioner aged about 14 years is suffering from cancer and under treatment at Dr. RPGMC Tanda, District Kangra.
