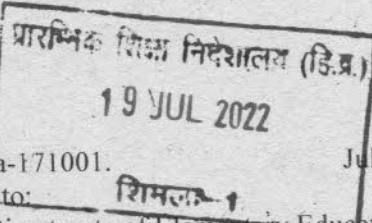
**In the matter :** CWP No.3907/2022 titled as Sunita Devi,TGT(Med)VS State of H.P. & others.

The Petitioner Smt. Sunita Devi,TGT(Med), filed CWP No. 3907/2022 titled as, Sunita Devi,TGT(Med), versus State of H.P. before the Hon'ble High Court of H.P.regarding her transfer from GSSS Sagnam,Distt. Lahul Spiti(which under tribal /difficult area) to her choice of station after the completion of required tenure as per policy.The case of the petitioner was listed before the Hon'ble High Court, on 20<sup>th</sup> June.2022, when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions / order:

*"In the given circumstances, we dispose of the instant petition by directing the respondents to consider the case of the petitioner for her transfer to Govt. High School Nairi (under cluster GSSS Fozal), District Kullu and if it is not possible to accommodate the petitioner in the nearby station .However,before doing so, the respondent shall call upon the petitioner to give station(s) of her choice .The entire exercise be completed within a period of four weeks from today".*

As per direction of the Hon'ble High Court the petitioner appeared through video conference for personal hearing on dated 30<sup>th</sup> June,2022 and she has requested that she may be adjusted GHS Piplage u/c GSSS Bhunter (KLU),GHS Sarsari (KLU),GSSS Bhekhali, GSSS Mohal Distt. Kullu against vacancy (caused due to promotion of present incumbent) or GMS Sim(KLU)( on upgradation).The petitioner has further stated that her parents are suffering from various old age ailments and there is no one in the family to look after them.

From the perusal of the record, it reveals that Smt.Sunita Devi TGT (Med), has been working in GSSS Sagnam District (L&S) since 20<sup>th</sup> Nov.2018, has completed her normal tenure at present place of posting. Hence keeping in view the representation of the petitioner is considered sympathetically and she is hereby transferred from GSSS Sagnam(L&S) to GSSS Mohal District Kullu against vacancy being caused due to promotion of present incumbent .These orders will be implemented after the relieving of incumbent who is going to be promoted. With these observations the representation of the petitioner is considered and disposed of accordingly.
