In the matter of: CWP No. 3513/2022 titled as Veena Devi Vs. State of H.P. & Others.

Whereas, Smt. Veena Devi, TGT (NM) preferred CWP No. 3513/2022 titled as Veena Devi Vs. State of H.P. before the Hon'ble High Court of H.P. regarding her transfer from GSSS Janjheli Distt. Mandi to her native place. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 3.06.2022 when the Hon'ble High Court has passed the following orders:-

*"4. Therefore, without going into the merits of the case and leaving the question, whether the area, where the petitioner is serving is "sub-cadre hard area" or not, open, we deem it appropriate to dispose of this petition by directing the respondents to consider the case of the petitioner for her transfer, only in case area falls within "sub-cadre hard area" and if it does, then, appropriate orders of transfer of the petitioner be issued to one of the soft area stations of her choice, as mentioned by her in ground 'e' of grounds of petition, within period of four weeks from today.*

*For compliance to come up on 15.7.2022."*

Whereas, petitioner has stated in her writ petition at para-5 that her ailing mother in law and father in law are more than eighty years old and no female member is there in the family to look after them, hence, she may be adjusted at GSSS Dev Bararta, GSSS(G) Sarkaghat, GSSS Bagra Galoo/GMS Chimba Balh under complex GSSS Bhadarwar/GSSS Parsada Hawani/GSSS Nabahi/GSSS Rissa/GSSS Maseran District Mandi.

From perusal of record, it has been found that the petitioner has been working GSSS Janjheli Distt. Mandi since 6.3.2019 and has completed more than three years stay at her present place of posting. One post of TGT(NM) is going to be vacant due to promotion of present incumbent in GSSS Bagra Galoo District Mandi as Lecturer in near future. Keeping in view the above facts and circumstances, the case of the petitioner is considered sympathetically and she is hereby transferred from GSSS Janjheli District Mandi to GSSS Bagra Galoo District Mandi against vacancy likely to be caused due to promotion of present incumbent as Lecturer in near future. These orders will be implemented after the relieving of the present incumbent on promotion. The representation of the petitioner is disposed of accordingly.

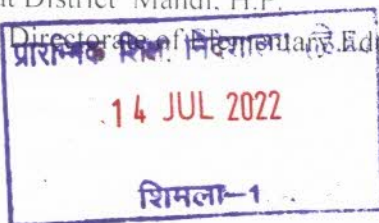
