CWP No. 2367/2022 titled as Sher Singh Vs State of H.P. & Others.

Whereas, Sh. Sher Singh, TGT (NM) preferred CWP No. 2367/2022 titled as Sher Singh Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GMS Sarli u/c GSSS Panjain Distt. Mandi to his native place. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 20.04.2022 when the Hon'ble High Court has passed the following orders:-

"4. Accordingly, without adverting to the merits of the case, this writ petition is disposed of with a direction that in case the petitioner moves a fresh representation to the respondents in terms of the transfer policy, dated 10th July, 2013, within a week from today, then respondents shall dispose of the same within two weeks from the receipt of the representation, in accordance with law.

5. Pending application(s), if any, also stand disposed of."

Whereas, petitioner submitted his representation to this office 29.4.2022 vide which he has requested that he has given five stations of his choice in District Mandi but there was no post of TGT(NM) is lying vacant in these schools. However, the petitioner has submitted another representation to this office on 11.7.2022 vide which he has requested that he may be transferred/adjusted at GSSS Sarni District Mandi against vacancy.

From perusal of record, it has been found that the petitioner has been working GMS Sarli u/c GSSS Panjain District Mandi since 11.3.2019 and has completed three years stay there. One post of TGT(NM) is lying vacant in GSSS Sarni District Mandi. Keeping in view the above facts and circumstances, the representation of the petitioner is considered sympathetically and he is hereby transferred from GMS Sarli u/c GSSS Panjain District Mandi to GSSS Sarni District Mandi against vacancy, without TTA/JT. The representation of the petitioner is disposed of accordingly.

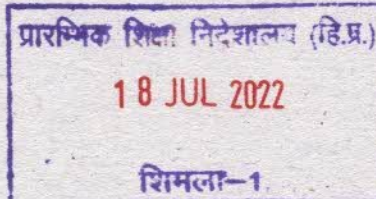
