However, the petitioner has submitted another representation to this office on 11.7.2022 vide which he has requested that he may be transferred/adjusted at GSSS Sarni District Mandi against vacancy.

From perusal of record, it has been found that the petitioner has been working GMS Sarli u/c GSSS Panjain District Mandi since 11.3.2019 and has completed three years stay there. One post of TGT(NM) is lying vacant in GSSS Sarni District Mandi, Keeping in view the above facts and circumstances, the representation of the petitioner is considered sympathetically and he is hereby transferred from GMS Sarli u/c GSSS Panjain District Mandi to GSSS Sarni District Mandi against vacancy, without TTA/JT. The representation of the petitioner is disposed of accordingly.
