In the matter of: CWP No. 1963/2022 titled as Sudhir Kumar Vs. State of H.P. & Others.

Whereas, Sh. Sudhir, TGT (NM) preferred CWP No. 1963/2022 titled as Sudhir Kumar Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GHS Banala u/c GSSS Lagauti Distt. Kullu to his native place. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 19.09.2018 when the Hon'ble High Court has passed the following orders:-

"5. Accordingly, the present writ petition is disposed of with a direction to the respondents to consider the case of the petitioner for posting at any stations as set out in the representation (Annexure P-4), in accordance with law within a period of four weeks from today. Pending application(s), if any, also stands disposed of."

Whereas, the petitioner has submitted his representation to this office on 16.6.2022 in which he has stated that he may be adjusted in GHS Majhiar/GSSS Amroh/GHS Bhaloon/GSSS Jol Sapper/Bhoranj/GHS Dhirwin District Hamirpur on promotion and GSSS Nalti District Bilaspur against vacancy due to his adverse family circumstances as his old age mother is residing alone in his native place and no body is there who lookafter his mother except him.

From perusal of record, it has been found that the petitioner has been working in GMS Banala u/c GSSS Lagauti District Kullu since 19.9.2018 and has completed more than three years stay at his present place of posting. One post of TGT(NM) is going to be vacant due to promotion of present incumbent in GHS Majhiar District Hamirpur as Lecturer in near future. Keeping in view the above facts and circumstances, the representation of the petitioner is considered sympathetically and he is hereby transferred on his own request from GMS Banala u/c GSSS Lagauti District Kullu to GHS Majhiar District Hamirpur against vacancy likely to be caused due to promotion of present incumbent as Lecturer in near future. These orders will be implemented after the relieving of the present incumbent on promotion. The representation of the petitioner is disposed of accordingly.
