In the matter of: CWP No. 3442/2022 titled as Nag Singh Vs. State of H.P. & Others.

Whereas, Sh. Nag Singh, TGT (NM) preferred CWP No. 3442/2022 titled as Nag Singh Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GHS Gahang u/c GSSS Thaltukhod Distt. Mandi to his native place. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 1.06.2022 when the Hon'ble High Court has passed the following orders:-

"4. Accordingly, without advertng to the merits of the case, this writ petition is disposed of with a direction to respondent No. 2 to dispose of the representation (Annexure P-3), moved by the petitioner expeditiously, in accordance with law, preperably within two weeks from the date of receipt of the copy of this order.

5. Pending application(s), if any, also stand disposed of."

Whereas, petitioner submitted his representation to this office 7.6.2022 vide which he has requested that he has completed more than three years stay at his present place of posting which is a hard/sub-cadre area and entitled for transfer to the station of his choice. He has further requested that he may be adjusted/transferred to GHS Seru u/c GGSSS Jogindernagar (Mandi)/GHS Matroo(Mandi)/GBSSS Jogindernagar Distt. Mandi/GSSS Bihun Distt. Mandi against vacancy likely to be caused due to promotion of present incumbent/GSSS Bir (Kangra).

From perusal of record, it has been found that the petitioner has been working GHS Gahang u/c GSSS Thaltukhod District Mandi since 11.12.2018 and has completed more than three years stay there. One post of TGT(NM) is going to be vacant due to promotion of present incumbent at GSSS Bihun District Mandi. Keeping in view the above facts and circumstances, the representation of the petitioner is considered sympathetically and he is hereby transferred from GHS Gahang u/c GSSS Thaltukhod District Mandi to GSSS Bihun District Mandi against vacancy likely to be caused due to promotion of present incumbent near future, without TTA/JT. These orders will be implemented after the relieving of present incumbent on promotion. The representation of the petitioner is disposed of accordingly.

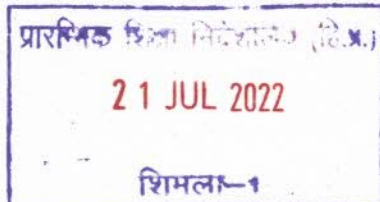
