In the matter of: CWP No: 4562/2022- titled as Dharam Deva, TGT (Arts) Vs. State of Himachal Pradesh (Regarding Transfer).

Sh. Dharam Deva, TGT(Arts) has filed CWP No. 4562/2022- before the Hon'ble High Court of H.P. regarding transfer from GMS Hibra u/c GSSS Gehra, Distt.Chamba. The case was listed on 12.07.2022, when the same has been disposed of with the following directions:-

*The petitioner to file a fresh representation within one week from today clearly setting out therein five stations of his choice , out of which one of the stations has essentially to be out of his home District. On receipt of such representation, the same shall be considered and decided by the respondents by issuing necessary consequential order of transfer within a period of four weeks.*

*However, it is made clear that the respondent shall consider the case of the petitioner for transfer and shall also consider the consent letter (Annexure P-6) given by one Shri Rajesh Kumar, who is ready to serve at the place of petitioner.*

*Pending application (s),if any, also stands disposed of.*

In compliance of the aforesaid orders passed by the Hon'ble High Court of Himachal Pradesh, the petitioner has submitted his representation, vide which he stated that he was appointed as TGT (Arts) on 01.12.2014 in GSSS Sunara, which is a sub cadre area of Distt. Chamba and again transferred to sub cadre i.e GMS Hibra u/c GSSS Gehra (Chamba) on 19.06.19. He has requested that due to adverse family circumstances, he may kindly be transferred from GMS Hibra u/c GSSS Gehra, Distt.Chamba to GSSS Bakani vice the present incumbent on consent basis/ GSSS Lylh / GHS Darwin /GHS Tralla/ GMSSS Mehla, Distt.Chamba/ GMS Bardi u/c GSSS Aundh (Kangra).

From the perusal of record, it is found that Sh. Dharam Deva, TGT(Arts) is working in GMS Hibra u/c GSSS Gehra, Distt. Chamba (Sub Cadre) since 20.06.2019 and has completed normal tenure at his present place of posting. The aforesaid school i.e GSSS Sunara and GMS Hibra u/c GSSS Gehra exists in sub cadre area of Distt. Chamba. One Sh. Rajesh Kumar, TGT(Arts) is working in GSSS Bakani, Distt.Chamba has given his consent for transfer from GSSS Bakani, Distt.Chamba to GMS Hibra u/c GSSS Gehra (Chamba). He has working in GSSS Bakani (Chamba) since 10.01.19 and has completed normal tenure at his present place of posting. Keeping in view the position stated above, representation of petitioner i.e Sh. Dharam Deva, TGT (Arts) is considered sympathetically and he is hereby transferred from GMS Hibra u/c GSSS Gehra, Distt. Chamba to GSSS Bakani, Distt.Chamba vice Sh. Rajesh Kumar, TGT (Arts) and vice versa. The representation of the petitioner is disposed of accordingly.
