In the matter of: CWP No: 4439/2022-titled as Santosh Kumar, TGT (Arts) Vs. State of Himachal Pradesh (Regarding Transfer)

Sh. Santosh Kumar, TGT(Arts) has filed CWP No. 4439/2022-before the Hon'ble High Court of H.P. regarding transfer from GSSS Thaltukhod, Distt. Mandi. The case was listed on 06.07.2022, when the same has been disposed of with the following orders :-

Case of the petitioner is that he has already completed normal tenure in difficult / hard area where he was posted since 29.03.2018. The petitioner has made a representation (Annexure P-4) for transfer to a place of his choice.

In the aforesaid facts and circumstances of the case, We dispose of this writ petition by directing respondent No.2- Director, Elementary Education, Himachal Pradesh, to decide the said representation, expeditiously and in any event, within four weeks from today. Pending applications to also stand disposed of accordingly.

In compliance of the aforesaid orders passed by the Hon'ble High Court of Himachal Pradesh, the representation (Annexure P-4) filed by the petitioner was perused wherein the petitioner i.e Sh. Santosh Kumar, TGT(Arts) stated that he has completed his normal tenure in sub cadre area and requested that he may kindly be transferred from GSSS Thaltukhod, Distt. Mandi (Sub Cadre) to GMS Balakrupi u/c GSSS Jogindernagar / GHS Sagnehar /GSSS Chauntra /GSSS (B) Joginder Nagar, Distt. Mandi, against vacancy , being caused due to promotion/ retirement.

From the perusal of record, it is found that Sh. Santosh Kumar, TGT (Arts) is working in GSSS Thaltukhod, Distt. Mandi (Sub Cadre) since 29.03.18 and has completed normal tenure at his present place of posting. Keeping in view the position stated above, representation of petitioner i.e Sh. Santosh Kumar, TGT(Arts) is considered sympathetically and he is hereby transferred from GSSS Thaltukhod, Distt. Mandi to GSSS Chauntra, Distt. Mandi, against vacancy, being caused due to promotion of the present incumbent in near future, without TTA/JT. These orders will be implemented after the relieving of the present incumbent on promotion. The representation of the petitioner is disposed of accordingly.
