Whereas, Sh. Ankush Rana, TGT (NM) preferred CWP No. 3286/2022 titled as Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GSSS Rohal Distt. Shimla (hard/sub-cadre area) to the station near his native place. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 25.5.2022 when the Hon'ble High Court has passed the following orders:-

" 4. Accordingly, without advertng to the merit of the case, this writ petition is disposed of with a direction that in case the petitioner moves a fresh representation to the respondents, in terms of the transfer policy, dated 10th July, 2013, within a week from today, then respondents shall dispose of the same within two weeks of the receipt of the representation, in accordance with law."

Whereas, petitioner submitted his representation to this office on 28.5.2022 alongwith a copy of the above judgement. He has requested in his representation that he has completed more than three years stay in hard/sub-cadre area and entitled for transfer to the station of his choice near to his native place.

From perusal of record, it has been found that the petitioner has been working GSSS Rohal Distt. Shimla since 4.5.2019 and has completed more than three years stay there. One post of TGT(NM) is going to be vacant due to promotion of present incumbent at GSSS Banuri District Kangra. Keeping in view the above facts and circumstances, the representation of the petitioner is considered sympathetically and he is hereby transferred without TTA/JT from GSSS Rohal District Shimla to GSSS Banuri District Kangra against vacancy likely to be caused due to promotion of present incumbent as Headmaster near future. These orders will be implemented after the relieving of the present incumbent on promotion. The representation of the petitioner is disposed of accordingly.

Whereas, Sh. Suneet Kumar, TGT (NM) preferred CWP No. 2732/2022 titled as Suneet Kumar Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GMS Thandal u/c GSSS Purthi(Pangi) Distt. Chamba(hard/tribal area) to the station of his choice. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 5.5.2022 when the Hon'ble High Court has passed the following orders:-

"4. Accordingly, without adverting to the merits of the case, this writ petition is disposed of with a direction that in case the petitioner moves a fresh representation to the respondents, in terms of the transfer policy, dated 10th July, 2013, within a weeks from today, then respondents shall dispose of the same within two weeks of the receipt of the representation, in accordance with law. Pending application(s), if any, also stand disposed of."

Whereas, in the compliance to the orders passed by the Hon'ble High Court petitioner has submitted his representation to this office on 9.5.2022 vide which he has requested that he may be transferred from hard/tribal area to the station of his choice in his native place.

From perusal of record, it has been found that the petitioner has been working GMS Thandal u/c GSSS Purthi(Pangi) District Chamba since 19.11.2019 and has not completed three years stay at his present place of posting as per comprehensive guiding Principles for regulating the transfer notified by the Government vide letter dated 10.7.2013. Keeping in view the above facts and circumstances, the representation of the petitioner can not be considered till the completion of three years stay at his present place of posting. The representation of the petitioner is disposed of accordingly.
