Whereas, Sh. Naveen Soni, TGT (NM) preferred CWP No. 1265/2022 titled as Naveen Soni Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GSSS Triloknath Distt. Lahaul & Spiti (Tribal Area) to the station of his choice. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 8.3.2022 when the Hon'ble High Court has passed the following orders:-

" considering the submission made in the writ petition that petitioner has completed normal tenure in hard/tribal/difficult area, we dispose of the present writ petition by granting liberty to the petitioner to file a comprehensive representation in respect of his transfer to soft area, in accordance with transfer policy, to respondent No. 2 within a period of two weeks from today. In case such representation is preferred, the same shall be decided by the competent authority/respondent No. 2 within a further period of two weeks, in accordance with law and applicable transfer policy. The order, so passed, shall also be communicated to the petitioner. Pending applications, if any, also stand disposed of."

Whereas, in the compliance to the orders passed by the Hon'ble High Court petitioner submitted his representation to this office on 19.4.2022 vide which he had given five stations of his choice in District Hamirpur, one station of his choice in District Kangra and one station in Una but there was no post of TGT(NM) lying vacant in these schools. However, the petitioner has submitted a fresh representation to this office on 26.7.2022 vide which he has requested that he may kindly be adjusted/transferred to GMS Manihal u/c GSSS Amroh Distt. Hamirpur against vacancy likely to be caused due to promotion of present incumbent.

From perusal of record, it has been found that the petitioner has been working at GSSS Triloknath District Lahaul & Spiti since 18.3.2019 and has completed more than three years stay. One post of TGT(NM) is going to be vacant due to promotion of present incumbent at GMS Manihal u/c GSSS Amroh District Hamirpur. Keeping in view the above facts and circumstances, the representation of the petitioner is considered sympathetically and he is hereby transferred without TTA/JT from GSSS Triloknath District Lahaul & Spiti to GMS Manihal u/c GSSS Amroh District Hamirpur against vacancy likely to be caused due to promotion of present incumbent near future. These orders will be implemented after the promotion of present incumbent. The representation of the petitioner is disposed of accordingly.
