Smt. Ekta Sharma, TGT (Arts) has filed CWP No. 4691/2022-before the Hon'ble High Court of H.P. regarding transfer from GSSS (B) Kunihar , Distt. Solan. The case was listed on 15.07.2022, when the same has been disposed of with the following orders :-

The respondent to consider the case of the petitioner in terms of clause 5.2 of the aforesaid comprehensive guiding principles and issue consequential order of transfer to one of the following stations :-

- (i) GHS Phagoti u/c GSSS Raili Jajri .
- (ii) GSSS Amroh, Distt.Hamirpur
- (iii) GSSS Samirpur, Distt. Hamirpur.

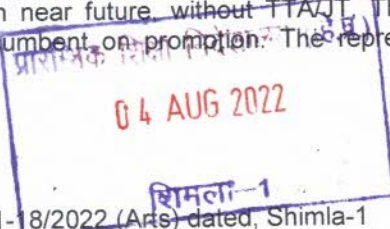
The instant petition is allowed , in the aforesaid terms, so also the pending application (s), if any.

In compliance to the aforesaid orders passed by the Hon'ble High Court of Himachal Pradesh, the representation (Annexure P-1) filed by the petitioner was perused wherein the petitioner i.e Smt. Ekta Sharma, TGT(Arts) stated that she is working in GSSS (B) Kunihar (Solan) w.e.f 14.11.2019 on contract basis and has been regularized w.e.f 24.04.2022. Her husband is serving in Indian Air Force w.e.f. 2011 and he remains out of State due to service exigencies and it is very difficult to look after her 6 year child and old aged in-laws. She has requested that due to adverse family circumstances she may kindly be transferred from GSSS (B) Kunihar (Solan) to Bhoranj or nearby against vacancy, being caused due to promotion of Headmasters and Lecturer amongst TGT's in near future.

From the perusal of record, it is found that Smt. Ekta Sharma, TGT(Arts) is working in GSSS (B) Kunihar (Solan) since 14.11.2019 and has not completed her normal tenure at her present place of posting. As per clause 5.2 of the comprehensive Guiding Principles-2013 **Concession to the wives of soldiers** : *The wives of Officers/Officials of Military /Central Para Military Forces will as far as possible be posted /appointed at convenient places subject to availability.*

Keeping in view the position stated above, representation of petitioner i.e Smt. Ekta Sharma, TGT(Arts) is considered sympathetically and she is hereby transferred from GSSS (B) Kunihar , Distt. Solan to GSSS Amroh, Distt. Hamirpur, against vacancy, being caused due to promotion of the present incumbent in near future, without TTA/JT. These orders will be implemented after the relieving of the present incumbent on promotion. The representation of the petitioner is disposed of accordingly.

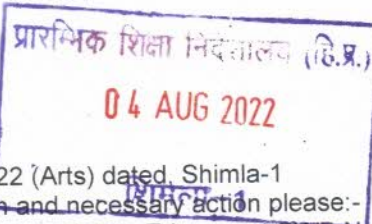
In the matter of: CWP No: 4585/2022-titled as Ashish Kumar, TGT (Arts) Vs. State of Himachal Pradesh (Regarding Transfer)

Sh. Ashish Kumar, TGT(Arts) has filed CWP No. 4585/2022-before the Hon'ble High Court of H.P. regarding transfer from GSSS Khunachi, Distt.Mandi. The case was listed on 13.07.2022, when the same has been disposed of with the following orders :-

The petitioner has filed the representation dated 4.5.2022 (Annexure P-1) but it is lacking in complete particular of choices. Therefore, the petitioner is permitted to make a fresh representation within one week from today. If such representation is made within one week from today, the same shall be decided expeditiously and in any event within four weeks from the date of receipt of the representation. Petition to stand disposed of. Pending applications, if any, also to stand disposed of.

In compliance to the aforesaid orders passed by the Hon'ble High Court of Himachal Pradesh, the petitioner has submitted his representation, vide which he stated that he is working in GSSS Khunachi, Distt.Mandi and completed a tenure of 5years at his present place of posting. He has also stated that his father has passed away and mother is also around 80 years old. She is a freedom fighter and there is no one to take care of her. He has requested that due to adverse family circumstances, he may kindly be transferred from GSSS Khunachi, Distt.Mandi to GMS Kakrana (Una)/ GSSS Bair / GSSS Giara Gran (Hamirpur)/GSSS Parnali (Bilaspur)/ GSSS Saroh (Una) against vacancy , being caused due to promotion.

From the perusal of record, it is found that Sh. Ashish Kumar, TGT(Arts) is working in GSSS Khunachi, Distt. Mandi since 09.10.2017 and has completed normal tenure at his present place of posting. Keeping in view the position stated above, representation of petitioner i.e Sh. Atul Kumar, TGT(Arts) is considered sympathetically and he is hereby transferred from GSSS Khunachi, Distt.Mandi to GSSS Biar, Distt. Hamirpur, against vacancy, being caused due to promotion of the present incumbent in near future, without TTA/JT. Sh. Ranvir Singh, TGT(Arts) has filed CWP No. 4525/2022- before the Hon'ble High Court of H.P. regarding transfer from GHS Malana, Distt.Kullu. The case was listed on 11.07.2022, when the same has been disposed of with the following orders :-

The present petition to stand disposed of by directing respondent No.2 to decide the representation (Annexure P-2) within three weeks from the date of production of copy of this order by the petitioner. Pending miscellaneous application(s), if any, shall also stand disposed of.

In compliance to the aforesaid orders passed by the Hon'ble High Court of Himachal Pradesh, the representation (Annexure P-2) filed by the petitioner was perused wherein the petitioner i.e Sh.
