Whereas, Sh. Pankaj Mohan, TGT (NM) preferred CWP No. 3530/2022 titled as Pankaj Mohan Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GSSS Kutwa Distt. Kullu to the station near his native place. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 3.6.2022 when the Hon'ble High Court has passed the following orders:-

*" 3. Accordingly, without adverting to the merit of the case, we dispose of the petition with direction to respondent No. 2 to dispose of the representation (Annexure P-3), moved by the petitioner expeditiously, in accordance with law, preferably within two weeks from receipt of the copy of this order."*

Whereas, petitioner submitted his representation to this office on 16.7.2022 vide which he has requested that he has completed more than three years stay in hard/sub-cadre area and entitled for transfer to the station of his choice near to his native place. He has given four stations of his choice.

From perusal of record, it has been found that the petitioner has been working at GSSS Kutwa Distt. Kullu since 12.3.2019 and has completed more than three years stay there. One post of TGT(NM) is going to be vacant due to promotion of present incumbent at GSSS (B) Jogindernagar District Mandi. Keeping in view the above facts and circumstances, the representation of the petitioner is considered sympathetically and he is hereby transferred without TTA/JT from GSSS Kutwa District Mandi to GSSS(Boys) Jogindernagar District Mandi against vacancy likely to be caused due to promotion of present incumbent as Lecturer near future. These orders will be implemented after the relieving of the present incumbent on promotion. The representation of the petitioner is disposed of accordingly.

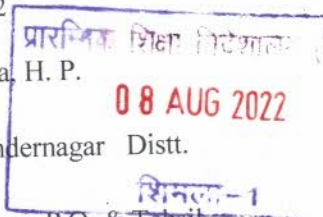
