ORDER

In the matter of: CWP No: 4075/2022--titled as Lalita Devi; TGT (Arts) Vs. State of Himachal Pradesh (Regarding Transfer)

Smt. Lalita Devi, TGT (Arts) has filed CWP No. 4075/2022-before the Hon'ble High Court of H.P. regarding transfer from GMS Lahal u/c GSSS Khani, Distt.Chamba. The case was listed on 27.06.2022, when the same has been disposed of with the following orders :-

The petitioner to make a fresh representation giving details of five stations of choice in two Districts in soft area. If such representation is filed within one week from today, the same shall be decided within one two weeks thereafter.

With these directions, the petition is disposed of, so also the pending miscellaneous applications, if any.

In compliance to the aforesaid orders passed by the Hon'ble High Court of Himachal Pradesh, the petitioner has submitted her representation, vide which she stated that she may kindly be transferred from Tribal area to one of the choice station i.e GHS Dhagoh u/c GSSS Nainikhad / GMS Tritha u/c GSSS Nainikhad / GSSS Nainikhad, Distt. Chamba / GSSS Khuwada Near Sulyali (Kangra) / GSSS Sadwan / Sulyali (Kangra).

From the perusal of record, it is found that Smt. Lalita Devi, TGT (Arts) is working in GMS Lahal u/c GSSS Khani (Tribal area) Distt.Chamba since 01.07.2006 and has completed 16 years tenure at her present place of posting. At present post of TGT (Arts) is not lying vacant in the above mentioned schools. However, one Sh. Krishan Chand, TGT(Arts) is working in GHS Dagoh u/c GSSS Nainikhad, Distt.Chamba since 27.05.2016 and has completed normal tenure at his present place of posting. Keeping in view the position stated above, representation of petitioner i.e Smt. Lalita Devi, TGT (Arts) is considered sympathetically and she is hereby transferred from GMS Lahal u/c GSSS Khani, Distt. Chamba to GHS Dagoh u/c GSSS Nainikhad, Distt.Chamba vice Sh. Krishan Chand, TGT (Arts) and vice versa with TTA/JT to Sh. Krishan Chand, TGT(Arts). The representation of the petitioner is disposed of accordingly.
