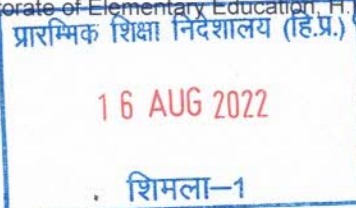

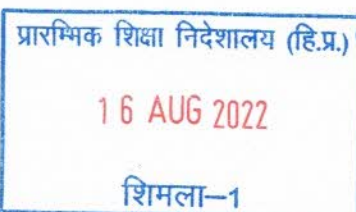



4. It must be ensured that the candidate is not specially abled.

5. It must be ensured that the candidate is not on the verge of retirement.

6. All provisions as contained in O/M No: PER (AP-3)E(3)17/2021 dated 10.07.2013 "Comprehensive guiding principles 2013 ----for regulating the transfer of State Govt. Employee at point no.5" consession to certain categories of employees and 5.5 of O/M dated 17.09.2015 must be adhered strictly.

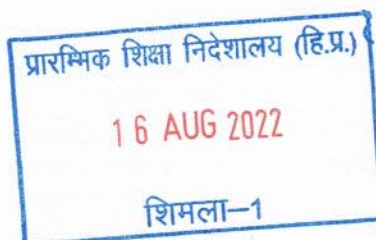
