ORDER

In the matter of:

CWP No. 2321/2022 titled as Satish Kumar Vs. State
of H.P. & Others.

Whereas, Sh. Satish Kumar, TGT (NM) preferred CWP No. 2321/2022 titled as Satish Kumar Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GSSS Liyo (Kinnaur) to the station of his choice. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 19.4.2022 when the Hon'ble High Court has passed the following orders:-

"2. During hearing of the case, learned counsel for the petitioner fairly submitted that the petitioner was initially appointed as T.G.T. (Non-Medical) on contract basis on 18.11.2019 and further that till date, the petitioner is serving on contract basis. It was also pointed out that in terms of Clause 7 of the above mentioned Transfer Policy, petitioner being a contractual appointee, has not completed his normal tenure of three years at his present place of posting. Be that as it may, We find from the record that the representations of the petitioner dated 23.02.2022 (Annexure P-1) and 15.03.2022 (Annexure P-2) are yet pending consideration before respondent No. 2. Therefore, we dispose of the instant writ petition by directing respondent No. 2/competent authority to decide the representations preferred by the petitioner at Annexure P-1 dated 23.2.2022 and Annexure P-2 dated 15.3.2022 within a period of two months from today by passing a speaking order, in accordance with law. The copy of order, so passed, shall also be communicated to the petitioner. Pending applications, if any, also stand disposed of.

Whereas, in the compliance to the orders passed by the Hon'ble High Court petitioner has submitted his representation to this office on 8.5.2022 vide which he has requested that he may be transferred from hard/tribal area to the station of his choice of his native place.

From perusal of record, it has been found that the petitioner has been working at GSSS Liyo District Kinnaur since 18.11.2019 and has not completed three years stay at his present place of posting as per comprehensive guiding Principles for regulating the transfer notified by the Government vide letter dated 10.7.2013. Keeping in view, the above facts and circumstances, the representation of the petitioner can not be considered till the completion of three years stay at his present place of posting. The representation of the petitioner is disposed of accordingly.
