CWP No. 2560/2022 titled as Paramjeet Kumar Vs. State of H.P. & Others.

Whereas, Sh. Paramjeet Kumar, TGT (NM) preferred CWP No. 2560/2022 titled as Paramjeet Kumar Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GHS Shalagad u/c GSSS Thachi Distt. Mandi to the station of his choice near his native place. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 28.4.2022 when the Hon'ble High Court has passed the following orders:-

" 4. Accordingly, without advertng to the merits of the case, this writ petition is disposed of with a direction that in case the petitioner moves a fresh representation to the respondents, in terms of the transfer policy, dated 10th July, 2013, within a week from today, then respondents shall dispose of the same within two weeks of the receipt of the representation, in accordance with law. Pending application(s), if any also stand disposed of."

Whereas, petitioner submitted his representation to this office on 7.5.2022 vide which he has requested that he has completed more than three years stay at his present place of posting and is entitled for transfer. He has given five stations of his choice in District Kangra which are not in accordance with Comprehensive Guiding Principles for regulating to the transfers of State Government employees. Hence the petitioner has given the fresh representation on 16.7.2022 vide which he has requested to transfer him from present place of posting to GSSS Dhawala (Kangra)/GMS Serabari u/c GMSSS(B)Dehra/GSSS Kutiara/GGSSS Jawalamukhi (Kangra)/GBSSS Naduan Distt. Hamirpur.

From perusal of record, it has been found that the petitioner has been working at GHS Shalagad u/c GSSS Thachi Distt. Mandi since 6.3.2019 and has completed three years stay there. One post of TGT(NM) is going to be vacant due to the promotion of present incumbent at GSSS Dhawala District Kangra. Keeping in view, the above facts and circumstances, the representation of the petitioner is considered sympathetically and he is hereby transferred without TTA/JT from GHS Shalagad u/c GSSS Thachi District Mandi to GSSS Dhawala District Kangra against vacancy likely to be caused due to promotion of present incumbent in near future. These orders will be implemented after the relieving of the present incumbent on promotion. The representation of the petitioner is disposed of accordingly.
