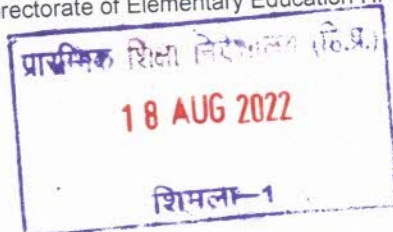
1. These orders be implemented in relaxation of ban on transfer.
2. In case of Condonation of short stay willingness of the concern incumbent may be obtained first.
3. Willingness of the concerned teacher be obtained by the in charge/Head of the institution before relieving him/her. In case he/she is not willing for the transfer, then he/she may not be relieved and the case may be referred back along with his/her unwillingness in r/o mutual transfers.
4. If the incumbent has already served sub-cadre/hard/tribal/difficult area in that event he/she not relieved again to areas ibid.
5. It must be ensured that the candidate is not specially abled.
6. It must be ensured that the candidate is not on the verge of retirement.
7. All provisions as contained in O/M No: PER (AP-3)E(3)17/2021 dated 10.07.2013 "Comprehensive guiding principles 2013 -for regulating the transfer of State Govt. Employee at point no.5" concession to certain categories of employees and 5.5 of O/M dated 17.09.2015 must be adhered strictly.

 Copy forwarded for information and necessary action to the:-

With the directions that the incumbent working under your establishment be relieved immediately failing which disciplinary action will be initiated against the defaulter under the rules. It must also be ensured that there is no court case before the relieving/joining of the concerned officials. The joining of the new incumbent be accepted only after the previous incumbent has been relieved. He/She will also ensure that the joining and relieving report is sent by him/her to Dy. If the controlling officer does not comply with this procedure the salary of the surplus incumbent will be drawn from the salary of controlling officer. Transfer of teachers on contract basis/teacher may not be implemented vice regular teacher.
