ORDER

In the matter :

CWP No.4858 /2022 titled as Smt. Richa Mohini,TGT(Med) Vs state of H.P. & others

The Petitioner Smt. Richa Mohini, TGT, (Med), filed CWP No. 4858/2022 titled as Richa Mohini,TGT(Med), versus State of H.P. before the Hon'ble High Court of H.P. regarding her transfer from GMSSS Khushnagri Distt Chamba, (which fall under hard/Tribal area) to her choice of station after the completion of required tenure as per policy. The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 21<sup>st</sup> July,2022, when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions/ order:-

*" In such circumstances, we dispose of this petition by permitting the petitioner to file a fresh representation within two week's from today clearly setting out therein five stations of her choice, out of which one station essentially be out of her home District. On receipt of such representation, the same shall be considered and decided by the respondents by issuing necessary consequential order of transfer within a period of three weeks. Pending application(s), if any, also stand disposed of."*

As per direction of the Hon'ble High Court the petitioner was called for, personal hearing on dated 10<sup>th</sup> August,2022. The petitioner attended personal hearing on the scheduled date through video conference. During personal hearing, he has requested that he may be adjusted in GSSS Harchakian /GSSS Spail/GSSS Khatet/ GHS Prei Distt. Kangra and GSSS Bir Bagehra Distt. Hamirpur against vacancy/longer stayee or promotion of present incumbent.

From the perusal of the record, it reveals that Smt. Richa Mohini, TGT(Med), has been working in GMSSS Khushnagari Distt. Chamba since 10-05-2019(which fall under hard/ Tribal area) and has completed her normal tenure at present place of posting. Hence, the representation of the petitioner is considered sympathetically and she is hereby transferred from GMSSS Khushnagari Distt. Chamba to GSSS Spail Distt. Kangra against vacancy, without TTA/JT. With these observations the representation of the petitioner is considered and disposed of accordingly.

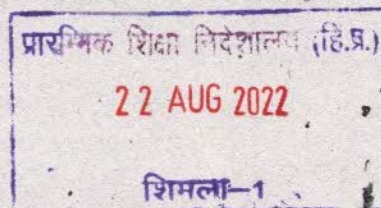
