ORDER

In the matter of: CWP No. 3535/2022 titled as Pramila Rani Vs. State of H.P. & Others.

Whereas, Smt. Pramila Rani, TGT (NM) preferred CWP No. 3535/2022 titled as Pramila Rani Vs. State of H.P. before the Hon'ble High Court of H.P. regarding her transfer from GSSS Chilli Distt. Chamba to the station of her choice. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 13.6.2022 when the Hon'ble High Court has passed the following orders:-

- “ 4. Accordingly, without advertng to the merits of the case, this writ petition is disposed of with a dirction that in case the petitioner moves a fresh representation to the respondents, in terms of the transfer policy, dated 10th July, 2013, within a week from today, then respondents shall dispose of the same within two weeks from the receipt of the representation, in accordance with law.
5. Pending application(s), if any, shall also stand disposed of.”*

Whereas, petitioner submitted her representation to this office on 18.7.2022 vide which she has requested that she has completed more than three years stay at her present place of posting i.e. GSSS Chilli District Chamba(hard/sub-cadre area) and is entitled for transfer to the station of her choice. She has given five stations of her choice in Kangra, Mandi & Chamba Districts.

From perusal of record, it has been found that the petitioner has been working at GSSS Chilli Distt. Chamba(sub-cadre area) since 30.3.2019 and has completed three years stay there. One post of TGT(NM) is going to be vacant due to the promotion of present incumbent at GMS Tanda u/c GSSS Rajpur District Kangra. Keeping in view, the above facts and circumstances, the representation of the petitioner is considered sympathetically and she is hereby transferred without TTA/JT from GSSS Chilli District Chamba to GMS Tanda u/c GSSS Rajpur District Kangra against vacancy likely to be caused due to promotion of present incumbent in near future. These orders will be implemented after the relieving of the present incumbent on promotion. The representation of the petitioner is disposed of accordingly.

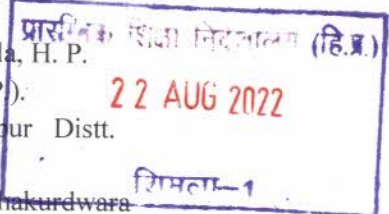
