ORDER

Sh. Atul Kumar, TGT (Arts) has filed CWP No. 4643/2022-before the Hon'ble High Court of H.P. regarding transfer from GMSSS Chowari, Distt.Chamba. The case was listed on 14.07.2022, when the same has been disposed of with the following orders :-

The representation so made by the petitioner shall be considered and decided by the respondents. Accepting the statement of learned Additional Advocate General, the petition is disposed of with a direction to the respondents to consider and decide the representation dated 19.05.2022 (Annexure P-2) made by the petitioner expeditiously and in any event within two weeks from today.

Petition to stand disposed of. Pending applications, miscellaneous applications, if any, also to stand disposed of.

In compliance to the aforesaid orders passed by the Hon'ble High Court of Himachal Pradesh, the representation (Annexure P-2) filed by the petitioner was perused wherein the petitioner i.e Sh. Atul Kumar, TGT (Arts) stated that he has completed normal tenure at his present place of posting. He has also stated that his father has passed away and there is no one to look after his old aged mother. He has requested that due to adverse family circumstances, he may kindly be transferred from GMSSS Chowari (Chamba) to GSSS Chhatar / GMSSS Rehan / GSSS Fatehpur, Distt.Kangra, against vacancy. But, there is no vacant post where the petitioner can be adjusted. Thereafter, the petitioner has submitted fresh representation on dated 18.08.2022, vide which he has mentioned five stations for transfer from GMSSS Chowari, Distt.Chamba to GMSSS Rehan/GSSS Barot/ GMSSS Fatehpur / GMSSS Giora (Kangra)/ GSSS Dhadu (Chamba) against vacancy, being caused due to promotion/ longer stayee.

From the perusal of record, it is found that Sh. Atul Kumar, TGT(Arts) is working in GMSSS Chowari, Distt.Chamba (Soft area) since 04.05.17 and has completed more than five years tenure at his present place of posting. At present post of TGT (Arts) is not lying vacant in the above mentioned schools. However, one Sh. Desh Raj, TGT(Arts) has been working in GSSS Dhadu, Distt. Chamba since 08.09.2006 and has completed his normal tenure at the present place of posting. Keeping in view the position stated above, representation of petitioner i.e Sh. Atul Kumar, TGT(Arts) is considered sympathetically and he is hereby transferred from GMSSS Chowari, Distt.Chamba to GSSS Dhadu, Distt. Chamba vice Sh. Desh Raj, TGT(Arts) and vice versa with TTA/JT to Sh. Desh Raj, TGT (Arts). The representation of the petitioner is disposed of accordingly.
