ORDER

In the matter of:

CWP No. 4692/2022 titled as Anjana Kumari Vs. State of H.P. & Others.

Whereas, Smt. Anjana Kumari, TGT (NM) preferred CWP No. 4692/2022 titled as Anjana Kumari Vs. State of H.P. before the Hon'ble High Court of H.P. regarding her transfer from GSSS Jauni Distt. Shimla to the station of her choice. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 15.7.2022 when the Hon'ble High Court has passed the following orders:-

" 4. Accordingly, we deem it proper to dispose of this writ petition, by directing the respondents to consider representation dated 5.7.2022(Annexure P-2), specifically in the light of Clause 5.4 of the Comprehensive Guiding Principles-2013, and take a decision within a period of four weeks from today. Pending application(s), if any, shall also stand disposed of. For compliance, to come up on 26.8.2022."

Whereas, petitioner submitted her representation to this office on 25.7.2022 vide which she has requested that she has completed more than three years stay at her present place of posting and is entitled for transfer. She has further submitted that she is suffering from various health problems. She has given three stations of her choice in Hamirpur District and one station of her choice in District Kangra.

From perusal of record, it has been found that the petitioner has been working at GSSS Jauni Distt. Shimla since 4.07.2019 and has completed three years stay there. One post of TGT(NM) is going to be vacant due to the promotion of present incumbent at Mair District Hamirpur due to promotion of present incumbent near future. Keeping in view, the above facts and circumstances, the representation of the petitioner is considered sympathetically and she is hereby transferred without TTA/JT from GSSS Jauni District Shimla to GSSS Mair District Hamirpur against vacancy likely to be caused due to promotion of present incumbent in near future. These orders will be implemented after the relieving of the present incumbent on promotion. The representation of the petitioner is disposed of accordingly.

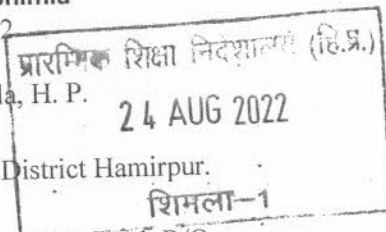
