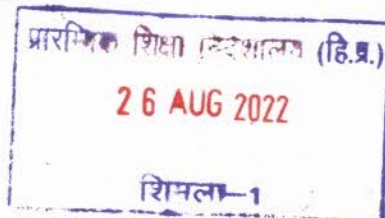
1. These orders may be implemented in relaxation of ban on transfers.

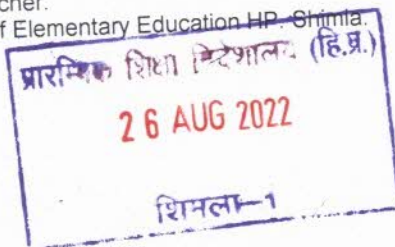
