In the matter :

CWP No.5401/2022 titled as Smt. Neema verma ,TGT(Med)  
Vs State of H. P. & others

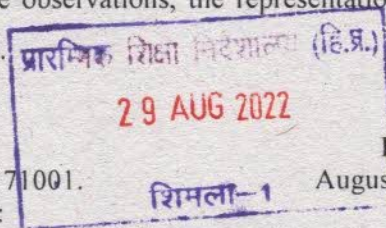
The Petitioner Smt. Neema Verma filed CWP No. 5401/2022 titled as Neema Verma,TGT (Med),versus State of H.P.before the Hon'ble High Court of H.P. regarding her transfer from GHS Gahang Distt. Mandi (which fall under hard area) to her choice of station after the completion of required tenure as per policy.The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 5<sup>th</sup> August,2022, when after hearing the matter,the Hon'ble High Court has disposed of the same with the following directions/ order:-

*" The petitioner seeks transfer from her present place of posting , which is stated to be hard/ difficult area ,under the policy of the respondents.It is the case of the petitioner that she has completed her normal tenure at the presnt place of posting*

*We dispose of the writ petition by permitting the petitioner to make a representation to respondent No.2-The Director of Elementary Education ,Himachal Pradesh. If such representation is made witin a period of one week from today,the same shall be decided expeditiously, but not later than six weeks from the date of receipt of the representation."*

As per direction of the Hon'ble High Court the petitioner submitted her representation to the undersigned ,in which she has requested that she may be adjusted in,GSSS(G) Joginder Nagar / GHS Bijan Dhalwan/ GSSS Padhar /GSSS Drang Distt. Mandi against vacancy caused due to promotion of present incumbent or any soft station vacant /longer stayee nearby Padhar Distt. Mandi .

From the perusal of the record, it reveals that, Smt. Neema Devi,TGT(Med)working in GHS Gahang u/c GSSS Thaltukhod,Distt. Mandi (which fall under hard area) since 8<sup>th</sup> June,2015,has completed her normal tenure at present place of posting. Keeping in view of the position stated above the representation of the petitioner is considered sympathetically and she is hereby transferred from GHS Gahang Distt. Mandi to GSSS(G) Jogindernagar,Distt.Mandi against vacancy being caused due to promotion of present incumbent.These orders will be implemented after the relieving of incumbent who is going to be promoted. With these observations, the representation of the petitioner is considered and disposed of accordingly .

**ORDER**

**In the matter :** CWP No. 5308/2022 titled as Monika Kumari,TGT(Med)VS State of H.P. & others.

The Petitioner,Smt. Monika Kumari,TGT (Med), filed CWP No. 5308/2022

titled as, Monika Kumari .versus State of H.P. before the Hon'ble High Court of H.P.regarding her transfer from GSSS Deothi (Balson) Distt. Shimla.The case of the petitioner was listed before the Hon'ble High Court, on 04<sup>th</sup> August,2022, when after hearing the matter, the Hon'ble High Court has disposed of the same with the direction to the respondent to transfer the petitioner from her present place of posting i.e.GSSS Deothi(Balson) Distt. Shimla.The operative portion of the judgement is as under:-

*"The petitioner is seeking her transfer from her present place of posting.she has made a representation dated 16-07-2022(Annexure P-1) to respondent No.2-Director,of Elementary Education,Shimla,H.P.*

*Learned counsel for the petitioner states that the petitioner would be satisfied,if her representation is decided by the respondent No.2 in time bound manner.*

*In the circumstances,we dispose of the writ petition by directing respondent No.2 to decide the representation of the petitioner expeditiously and in any event within three weeks from today."*

As per direction of the Hon'ble High Court the petitioner was called for personal hearing on dated 26<sup>th</sup> August,2022.The petitioner attended the personal hearing on scheduled date and time. During personal hearing the petitioner has requested that she may be adjusted at GSSS Chandpur (Against vacancy) /GSSS Daroh/GSSS Chowki /GHS Thandol Distt. Kangra / GSSS Lad Bharol Distt. Mandi against vacancy caused due to promotion of present incumbent. She has also stated that, she is under medical treatment from Fortis (Mohali) and has been advised complete rest.

From the perusal of the record, it reveals that Smt. Monika Kumari,TGT(Med), has been working in GSSS Deothi (Balson),Distt. Shimla since 01-08-2019 and has completed her normal tenure at present place of posting. Hence, the representation of the petitioner is considered sympathetically and she is hereby transferred from GSSS Deothi (Balson) ,Distt. Kangra to GSSS Daroh Distt. Kangra against vacancy being caused due to promotion of present incumbent .These orders will be implemented after the relieving of present incumbent who is going to be promoted. With these observations the representation of the petitioner is considered and disposed of according to the following directions:
