ORDER

In the matter of: CWP No. 5037/2022 titled as Ashok Kumar Vs. State of H.P. & Others.

Whereas, Sh. Ashok Kumar, TGT (NM) preferred CWP No. 5037/2022 titled as Ashok Kumar Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GSSS Nohradhar Distt. Sirmour(hard/sub-cadre area) to the station of his choice in soft area. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 27.7.2022 when the Hon'ble High Court has passed the following orders:-

" 2. Learned counsel for the petitioner seeks leave to withdraw the present writ petition with liberty to make a representation to respondent No. 2-Director of Elementary Education, Shimla. Accordingly, the writ petition is allowed to be withdrawn with liberty, as prayed. In case, the representation is made by petitioner within one week from today, the same shall be considered and decided by respondent No. 2, expeditiously and in any event by 31st August, 2022.

3. Pending miscellaneous application(s), if any, also stand disposed of."

Whereas, petitioner submitted his representation to this office on 29.07.2022 vide which he has given seven stations of his choice in soft area i.e. (i) GSSS Chauki Maniar (ii) GMS(G) Amba u/c GSSS Amb/GSSS Kalruhi/GSSS Daloh/GSSS Lohara/GMS Satothar u/c GSSS Dhusara District Una and GSSS Kaloha(Kangra) due to his adverse family circumstances.

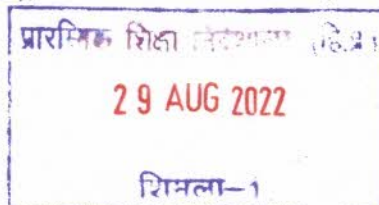
From perusal of record, it has been found that the petitioner has been working at GSSS Nohradhar Distt. Sirmour since 3.03.2014 and has completed more than eight years stay there. One post of TGT(NM) is going to be vacant due to the promotion of present incumbent at GSSS Chokimaniar District Una due to promotion of present incumbent near future. Keeping in view, the above facts and circumstances, the representation of the petitioner is considered sympathetically and he is hereby transferred without TTA/JT from GSSS Nohradhar District Sirmour to GSSS Chokimaniar District Una against vacancy likely to be caused due to promotion of present incumbent in near future. These orders will be implemented after the relieving of the present incumbent on promotion. The representation of the petitioner is disposed of accordingly.
