ORDER



In the matter :

**CWP No. 5018/2022 titled as Aniladhar Sharma
& others.**


The Petitioner Smt. Aniladhar Sharma filed CWP No. 5018/2022 titled as Aniladhar Sharma, TGT (Med), versus State of H.P. before the Hon'ble High Court of H.P. regarding her transfer from GSSS Somanachani, Distt. Mandi (which fall under hard/Tribal area) to her choice of station after the completion of required tenure as per policy. The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 27th July, 2022, when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions/ order:-

"The case of the petitioner is that he, a TGT(Med), has completed normal tenure at Government Senior Secondary School Somanachani, Tehsil Bali Chowki, Distt. Mandi, H.P. which falls in difficult area and therefore, he is due for transfer. It is pointed out that the petitioner has already made representations dated 9-11-2021 and 9-06-2022 (Annexure P-I) before the competent authority.

Therefore, without entering into the merits of the case, we dispose of the writ petition by direction respondent No.2-Director of H.P. Elementary Department Shimla, to decide the aforesaid representation expeditiously and in any event, within three weeks from the date of production of a copy of this order."

As per direction of the Hon'ble High Court the petitioner submitted her representation to the undersigned, in which she has requested that she may be adjusted at GSSS Trifalghat /GSSS Samaila / GSSS Kot Hatli /GSSS Gopalpur /GSSS Sarkaghat (Mandi) / GSSS Ghumarwin/GHS Pantehra /GHS Tiun Khas Distt. Bilaspur against vacancy caused due to promotion of present incumbent.

From the perusal of the record, it reveals that Smt. Aniladhar Sharma, TGT(Med), has been working in GSSS Somanachani (Balichowki) Distt. Mandi (which fall under hard/Tribal area), since 04-10-2017 and has completed her normal tenure at present place of posting. Hence, the representation of the petitioner is considered sympathetically and she is hereby transferred from GSSS Somanachani (Balichowki) Distt. Mandi to GSSS (Boys) Ghumarwin Distt. Bilaspur against vacancy being caused due to promotion of present incumbent. These orders will be implemented after the relieving of present incumbent who is going to be promoted. With these observations the representation of the petitioner is considered and disposed of accordingly.
