ORDER

In the matter of:

CWP No. 3622/2022 titled as Ajay Kumar Sharma Vs. State of H.P. & Others.



Whereas, Sh. Ajay Kumar Sharma, TGT (NM) preferred CWP No. 3622/2022 titled as Ajay Kumar Sharma Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GMS Karangla u/c GSSS Delath Distt. Shimla to the station of his choice. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 16.6.2022 when the Hon'ble High Court has passed the following orders:-

" 3. In the given facts and circumstances and without going into the merits of the case, we deem it proper to dispose of the petition by directing the respondents to consider the claim of the petitioner sympathetically in view of the grounds raised in the petition within a period of three weeks from today.

The petition stands disposed of in the aforesaid terms, so also the pending application(s), if any.

Whereas, petitioner submitted his representation to this office on 01.07.2022 vide which he had given five stations of his choice i.e. (i) GMS Dhanotu u/c GSSS Karot Distt Hamirpur (ii) GHS Sasan (iii) GMS Bharin u/c GSSS Kakriar/ GHS Barara District Hamirpur and GMS Batwara u/c GSSS Marhana District Bilaspur.

From perusal of record, it has been found that the petitioner has been working at GMS Karangla u/c GSSS Delath Distt. Shimla since 3.03.2014 and has completed more than eight years stay there. One post of TGT(NM) is going to be vacant due to the promotion of present incumbent at GMS Batwara u/c GSSS Marhana District Bilaspur due to promotion of present incumbent in near future. Keeping in view, the above facts and circumstances, the representation of the petitioner is considered sympathetically and he is hereby transferred without TTA/JT from GMS Karangla u/c GSSS Delath District Shimla to GMS Batwara u/c GSSS Marhana District Bilaspur against vacancy likely to be caused due to promotion of present incumbent in near future. These orders will be implemented after the relieving of the present incumbent on promotion. The representation of the petitioner is disposed of accordingly.

ORDER

In the matter of: CWP No. 7707/2021 titled as Neelam Kumar Vs. State of H.P. & Others.

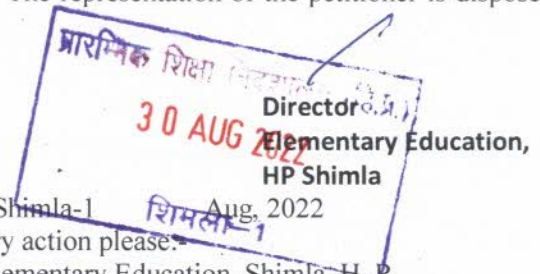
Whereas, Sh. Neelam Kumar, TGT (NM) preferred CWP No. 7707/2021 titled as Neelam Kumar Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GHS Chouridhar u/c GSSS Seri Banglow Distt. Mandi to the station of his choice. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 16.11.2021 when the Hon'ble High Court has passed the following orders:-

" 2. Accordingly, without advertting to the merits of the case, we dispose of the present petition by giving liberty to the petitioner to move a fresh representation to the respondent No. 2-Director of Elementary Education Shimla, Himachal Pradesh, within a period of one week from today and the said respondent shall dispose of the representation, in accordance with law, within 15 days of the receipt of the representation alongiwth copy of this order.

Pending miscellaneous application(s), if any, also stands disposed of."

Whereas, petitioner submitted his representation to this office on 10.12.2021 vide which he had given five stations of his choice but there was no vacancy in these schools. Now, the petitioner has given fresh representation on 15.6.2022 wherein he has given five stations of his choice in District Mandi against vacancy likely to be caused due to promotion of present incumbents.

From perusal of record, it has been found that the petitioner has been working at GSSS Chouridhar u/c GSSS Seri Banglow Distt. Mandi since 19.09.2018 and has completed more than three years stay there. One post of TGT(NM) is going to be vacant due to the promotion of present incumbent at GMS Chhimba Balh u/c GSSS Rissa District Mandi due to promotion of present incumbent in near future. Keeping in view, the above facts and circumstances, the representation of the petitioner is considered sympathetically and he is hereby transferred without TTA/JT from GHS Chouridhar u/c GSSS Seri Banglow District Mandi to GMS Chhimba Balh u/c GSSS Rissa District Mandi against vacancy likely to be caused due to promotion of present incumbent in near future. These orders will be implemented after the relieving of the present incumbent on promotion. The representation of the petitioner is disposed of accordingly.
