**ORDER**

In the matter of: CWP No: 5566/2022-titled as Bharat Bhardwaj, TGT(Arts) Vs. State of Himachal Pradesh (Regarding Transfer).

Sh. Bharat Bhardwaj, TGT (Arts) has filed CWP No. 5566/2022-before the Hon'ble High Court of H.P. regarding transfer from GSSS Padhechi, Distt.Shimla. The case was listed on 17.08.2022, when the same has been disposed of with the following orders :-

*The respondent No.2 to consider and decide the representation (Annexure P-6 moved by the petitioner expeditiously in accordance with law, preferably within three weeks from the date of receipt of copy of this order.*

*Pending miscellaneous application (s) if any, shall also stand disposed of.*

In compliance to the aforesaid orders passed by the Hon'ble High Court of Himachal Pradesh, the representation (Annexure P-6) filed by the petitioner was perused wherein the petitioner i.e Sh. Bharat Bhardwaj, TGT (Arts) stated that he was appointed as TGT (Arts) on 16.01.17 at GHS Padhechi, Distt.Shimla and has completed normal tenure at his present place of posting . He has also stated that his wife is working as a Female Health worker in Health Sub-Centre Ladda, under C.H.C Kuthera, Block Ghumarwin , Distt. Bilaspur, H.P and requested for transfer under Provision 5.4 of the Transfer Policy, from GSSS Padhechi (Shimla ) to GHS Taraun/ GMS Gassour u/c GSSS Jukhala /GSSS Talwara/ GHS Takrera u/c GSSS Ghumarwin, Distt.Bilaspur, against vacancy, being caused due to promotion/ superannuation.

From the perusal of record, it is found that Sh. Bharat Bhardwaj, TGT(Arts) is working in GSSS Padhechi (Shimla) since 16.01.17 and has completed more than five years tenure at his present place of posting. As per para 5.4 of the comprehensive Guiding Principles-2013 "***In case wife and husband both are working under the State Government efforts be made to post them at one place of near places as far as possible subject to vacancy.***

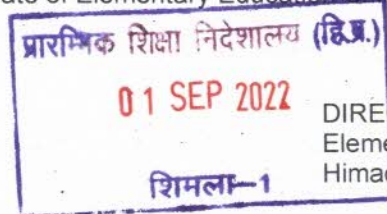
Keeping in view the position stated above, representation of petitioner i.e Sh. Bharat Bhardwaj, TGT(Arts) is considered sympathetically and he is hereby transferred from GSSS Padhechi , Distt. Shimla to GSSS Talwara, Distt. Bilaspur, against vacancy, being caused due to promotion of the present incumbent, without TTA/JT. These orders will be implemented after the relieving of the present incumbent on promotion. The representation of the petitioner is disposed of accordingly.
