## ORDER

Whereas, Smt. Anupma Chaudhary, TGT (NM) preferred CWP No. . 1899/2022 titled as Anupma Chaudhary Vs. State of H.P. before the Hon'ble High Court of H.P. against her transfer from GHS Guriyal u/c GSSS Raja Ka Talab Distt. Kangra to GSSS Kohal . District Chamba. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 09.8.2022 when the Hon'ble High Court has passed the following orders:-

There was no post of TGT(NM) lying vacant in the schools in the vicinity of Kangra. However, the petitioner was called for personal hearing on 16.8.2022 and she attended the same. At the time of hearing petitioner has submitted a fresh representation vide which she has given five stations of her choice i.e. (i) GSSS Makroli/GSSS Manoh Sihal/GSSS Rehan/GMS Nauri u/c GSSS Ban Bilwan/Ghati Bilwan/GHS

Panlth u/c GSSS Harsar District Kangra.

From perusal of record, it has been found that the petitioner was transferred from GHS Guriyal u/c GSSS Raja Ka Talab District Kangra to GSSS Kohal District Chamba vice Smt. Nisha Devi, TGT(NM) & vice-versa, on the completion of normal tenure of three years at her present place of posting. One post of TGT(NM) is going to be vacant due to the promotion of present incumbent at GSSS Rehan District Kangra due to promotion of present incumbent. Keeping in view, the above facts and circumstances, the representation of the petitioner is considered sympathetically and she is hereby adjusted without TTA/JT at GSSS Rehan District Kangra against vacancy being caused due to promotion of present incumbent. These orders will be implemented after the relieving of the present incumbent on promotion. The representation of the petitioner is disposed of accordingly.
