ORDER

In the matter of: CWP No. 1694/2022 titled as Pankaj Kumar Vs. State of H.P. & Others.

Whereas, Sh. Pankaj Kumar TGT (NM) preferred CWP No. 1694/2022 titled as Pankaj Kumar, Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GSSS Dharwas (Pangi) Distt. Chamba(hard/sub-cadre area) to District Kangra/Hamirpur in the school of his choice. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 28.7.2022 when the Hon'ble High Court has passed the following orders:-

" 4. Accordingly, without adverting to the merits of the case, this writ petition is disposed of with a direction that in case the petitioner moves a fresh representation to the respondents in terms of the Transfer policy dated 10th July, 2013, within a week from today, then respondents shall dispose of the same within two weeks from the receipt of the representation, in accordance with law. Pending application(s), if any, also stand disposed of."

Whereas, petitioner submitted his representation to this office on 2.04.2022 vide which he had requested to adjust him in the stations of his choice in District Kangra/Hamirpur but posts of TGT(NM) was not lying vacant in these school. The petitioner has also given a fresh representation on 31.8.2022 to this office vide which he has requested that one post of TGT(NM) is going to be vacant due to promotion of present incumbent at GGSSS Jawalamukhi District Kangra and he may be adjusted there.

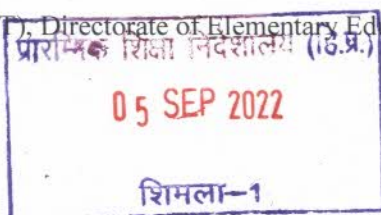
From perusal of record, it has found that the petitioner has been working in GSSS Dharwas District Chamba(hard/tribal area) w.e.f. 13.3.2019 and has completed more than three years stay there. Keeping in view, the above facts and circumstances, the representation of the petitioner is considered sympathetically and he is hereby transferred from GSSS Dharwas (Pangi) District Chamba to GGSSS Jawalamukhi District Kangra against vacancy being caused due to promotion of present incumbent. These orders will be implemented after the relieving of the present incumbent on promotion. The representation of the petitioner is disposed of accordingly.

Smt. Renu Bala, TGT (NM) preferred CWP No. 2528/2022-titled as Renu Bala Vs. State of H.P., before the Hon'ble High Court of H.P. regarding her transfer from GSSS Averi District Kangra to GMS Badsar u/c GSSS Jajhakothi District Chamba. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 27.4.2022 when the Hon'ble High Court has passed the following orders:-

" Learned counsel for the petitioner submits that he may be permitted to withdraw the petition, to enable the petitioner to approach the respondents by way of a representation.

2. Ordered accordingly.

Pending miscellaneous application(s), if any, shall also stand disposed of."

In compliance to the directions of the Hon'ble High Court, the petitioner has submitted her representation to this office vide which she has requested that she may be adjusted at the stations of her choice due to her adverse family circumstances. She has given six stations of her choice in District Kangra.

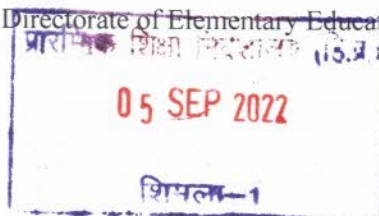
From perusal of record, it has been found that the petitioner has been transferred from GSSS Averi District Kangra to GMS Badsar u/c GSSS Jajhakothi District Chamba with the prior approval of competent authority on the completion of normal tenure of three years at her present place of posting, as she had been working there since 29.10.2017. However, she has requested to adjust her at GMS Khural u/c GSSS Khera District Kangra where post of TGT(NM) is going to be vacant due to promotion of present incumbent, due to her adverse family circumstances. Keeping in view, the above facts and circumstances, the representation of the petitioner is considered sympathetically and she is hereby adjusted at GMS Khural u/c GSSS Khera District Kangra against vacancy likely to be caused due to promotion of present incumbent. These orders will be implemented after the relieving of the present incumbent on promotion. The representation of the petitioner is disposed of accordingly.
