ORDER

In the matter of: CWP No. 5475/2022 titled as Shresta Devi Vs. State of H.P. & Others.

Whereas, Smt. Shresta Devi, TGT (NM) preferred CWP No. 5475/2022 titled as Shresta Devi Vs. State of H.P. before the Hon'ble High Court of H.P. regarding her transfer from GSSS Manpura Distt. Solan to District Kangra in her native place. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 10.8.2022 when the Hon'ble High Court has passed the following orders:-

- “ 3. However, since the representation made by the petitioner is still pending consideration before the respondents, therefore, we deem it appropriate to dispose of this petition by directing the respondents to consider and decide the representation of the petitioner within a period of four weeks..Ordered accordingly.*
- 4. However, it is made clear that this order is being passed in the peculiar facts and circumstances of the case and shall not be treated as a precedent in future.*
- 5. Pending application(s), if any, also stands disposed of.”*

Whereas, petitioner submitted her representation to this office on 17.08.2022 vide which she has requested to transfer her at GMS Heeru u/c GSSS Forsythganj/GHS Jheol u/c GSSS Mandal/GHS Haler Kalan District Kangra against vacancy on promotion/GSSS Gharoh District Kangra against longer stay.

From perusal of record, it has been found that the petitioner has been working at GSSS Manpura Distt. Solan since 9.07.2019 and has completed more than three years stay there. One post of TGT(NM) is going to be vacant due to the promotion of present incumbent at GMS Heeru u/c GSSS Forsythganj District Kangra in near future. Keeping in view, the above facts and circumstances, the representation of the petitioner is considered sympathetically and she is hereby transferred without TTA/JT from GSSS Manpura District Solan to GMS Heeru u/c GSSS Forsythganj District Kangra against vacancy likely to be caused due to promotion of present incumbent as Headmaster in near future. These orders will be implemented after the relieving of the present incumbent on promotion. The representation of the petitioner is disposed of accordingly.
