ORDER

In the matter of: CWP No. 5528/2022 titled as Rameshwar Dayal Vs. State of H.P. & Others.

Whereas, Sh. Rameshwar Dayal, TGT (NM) preferred CWP No. 5528/2022 titled as Rameshwar Dayal Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GMS Dakho u/c GSSS Reckong Peo District Kinnaur to the station of his choice. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 16.08.2022 when the Hon'ble High Court has passed the following orders:-

*"5. Accordingly, we dispose of this petition, by directing the respondents to consider and decide the representation of the petitioner within two weeks and pass consequential orders of transfer of the petitioner to any one of the aforesaid six stations. Pending application(s), if any, shall also stand disposed of."
For compliance, to come up on 13th September, 2022."*

In compliance to the above, the case of the petitioner has been examined and on perusal of the record, it is found that the petitioner has been working at GMS Dakho u/c GSSS Reckong Peo Distt. Kinnaur since the 13.3.2019 and has completed more than three years stay there. Keeping in view, the above facts and circumstances, the representation of the petitioner is considered sympathetically and he is hereby transferred without TTA/JT from GMS Dakho u/c GSSS Reckong Peo Distt Kinnaur to GSSS Domehar (K) District Solan against vacancy being casued vacant due to promotion of present incumbent. These orders will be implemented after the relieving of the present incumbent on promotion. The representation of the petitioner is disposed of accordingly.
