ORDER

In the matter of: CWP No: 5375/2022-titled as Ajeet Negi, TGT(Arts) Vs. State of Himachal Pradesh (Regarding Transfer).

Sh. Ajeet Negi, TGT (Arts) has filed CWP No. 5375/2022-before the Hon'ble High Court of H.P. regarding transfer from GSSS Kashapat, Distt. Shimla. The case was listed on 05.08.2022, when the same has been disposed of with the following orders :-

The respondents to consider and decide the case of the petitioner and then pass necessary consequential order of transfer by posting him at any of the stations mentioned hereinabove within a period of four weeks from today. Pending application (s), if any also stands disposed of.

In compliance to the aforesaid order/ judgment passed by the Hon'ble High Court of Himachal Pradesh, the representation filed by the petitioner was perused wherein the petitioner has given five station for transfer from GSSS Kashapat (Shimla) (Sub Cadre) to GSSS Sarahan/ GHS Shahdhar/ GMS Bathara /GMS Bonda (Shimla)/ GMS Brow (Kullu) against vacancy.

From the perusal of record, it is found that Sh.Ajeet Negi, TGT(Arts) is working in GSSS Kashapat (Shimla) (Sub Cadre) since 04.05.2017 and has completed more than five years tenure at his present place of posting. One post of TGT(Arts) is lying vacant in GHS Shahdhar, Distt. sShimla.

Keeping in view the position stated above, representation of petitioner i.e Sh. Ajeet Negi, TGT(Arts) is considered sympathetically and he is hereby transferred from GSSS Kashapat, Distt. Shimla to GHS Shahdhar, Distt. Shimla, against vacancy, without TTA/JT. The representation of the petitioner is disposed of accordingly.
