ORDER

In the matter :

**CWP No. 5296/ 2022 titled as Rajinder Singh,TGT (Med)
Vs State of H.P. & others.**

The Petitioner Rajinder Singh,TGT(Med) has filed CWP No. 5296/2022 titled as Sh. Rajinder Singh,TGT(Med) versus State of H.P. before the Hon'ble High Court of H.P. aggrieved his transfer from GSSS Parol (HMR) to GHS Alipabo (MND) vice Smt. Neema Devi.TGT(Med). The case of the petitioner was listed before the Hon'ble High Court on 24th August. 2022 when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions/ order:-

“ In the given fact and circumstances we direct the respondents to consider and decide the grievances of respondent No.4 after taking into consideration the correctness and veracity of the aforesaid facts and pass consequential order if so required within a period of four weeks from today.”

As per direction of the Hon'ble High Court the respondent No.4 was called for personal hearing on dated 14th Sep.2022.The petitioner attended the personal hearing on scheduled date and time. During personal hearing the petitioner has requested that she may be adjusted at in GSSS Jhagriani /GHS Ludder Mahadev/GSSS Parol Distt. Hamirpur against vacancy or longer stay.

The representation has been examined carefully and it has been revealed that the petitioner has been transferred from GSSS Parol (HMR) GHS Alipabo vice respondent No. 4 i.e. Smt.Neema Devi, TGT(Med) & vice-versa on the completion of normal tenure of three years as per policy. Now, in compliance to the orders passed by the Hon'ble High Court in aforesaid writ petition the representation of the respondent No. 4 is considered sympathically and she is hereby adjusted in GSSS Parol Distt. Hamirpur without TTA/JT against longer stay i.e.Sh. Rajinder Singh,TGT(Med) with TTA/JT. With these observations the representation of the respondent No. 4 is considered and disposed of accordingly.
