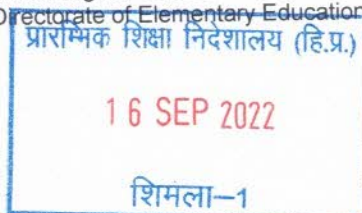

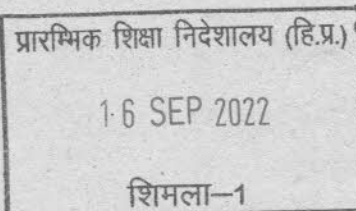

In case, any violation of these instructions you will be entirely responsible. These orders be implemented in relaxation of ban on transfer. These orders will be implemented after the relieving of present incumbent on promotion.

1. In case of Condonation of short stay willingness of the concern incumbent may be obtained first.
