ORDER

In the matter of: CWP No. 2530/2022 titled as Jagat Ram Vs. State of H.P. & Others.

Whereas, Sh. Jagat Ram, TGT (NM) preferred CWP No. 2530/2022 titled as Jagat Ram Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GMS Panjolath u/c GSSS Batwara District Mandi to the station of his choice. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 27.04.2022 when the Hon'ble High Court has passed the following orders:-

" 4. Accordingly, without advertng to the merits of the case, we deem it appropriate to dispose of the writ petition with a direction that in case the petitioner moves fresh representation before respondent No. 2, Director of Elementary Education, Himachal Pradesh, in terms of the Transfer Policy dated 10.7.2013, within one week from today, the same shall be disposed of by the said respondent, in accordance with law, within two weeks thereafter from the date of receipt of the representation alongwith copy of this order."

Whereas, petitioner submitted his fresh representation to this office on 6.05.2022 vide which he has requested to adjust/transfer him in the station of choice i.e. GMS Nalni u/c GSSS Maloh Tehsil Sundernagar Distt. Mandi/GMS Dehvi u/c GSSS Salppar Distt. Mandi/GMS Churad u/c GSSS Sundernagar/GMS Gamoh u/c GSSS Jarol/GSSS Haronda Distt. Bilaspur.

From perusal of record, it has been found that the petitioner has been working at GMS Panjolath u/c GSSS Batwara Distt. Mandi w.e.f. 3.10.2006 and has completed more than 16 years stay there. Keeping in view, the above facts and circumstances, the representation of the petitioner is considered sympathetically and he is hereby transferred without TTA/JT from GMS Panjolath u/c GSSS Batwara Distt Mandi to GMS Jamthal u/c GSSS Harnoda District Bilaspur against vacancy being caused vacant due to promotion of present incumbent. These orders will be implemented after the relieving of the present incumbent on promotion. The representation of the petitioner is disposed of accordingly.
