**ORDER**

In the matter of:

CWP No. 3484/2022 titled as Sanjeevan Kumar Vs. State of H.P. & Others.

Whereas, Sh. Sanjeevan Kumar, TGT (NM) preferred CWP No. 3484/2022 titled as Sanjeevan Kumar Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GSSS Dugli Tehsil Churah District Chamba(hard/sub-cadre area) to the station of his choice. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 02.06.2022 when the Hon'ble High Court has passed the following orders:-

" 3. Accordingly, without adverting to the merits of the case, we deem it appropriate to dispose of the writ petition with a direction to respondent No. 2, Director of Elementary Education, Himachal Pradesh, to dispose of the representation of the petitioner dated 26.4.2022(Annexure P-3), in accordance with law within a period of two weeks from the date of receipt of the copy of this order.  
4. Pending miscellaneous application(s), if any, shall also stand disposed of."

Whereas, petitioner submitted his representation to this office on 18.07.2022 vide which he had given five stations of his choice i.e. (i) GMS Balah u/c GMSSS Kotla Distt. Kangra/GSSS Jaunta Distt. Kangra/GSSS Kherian Nurpur Distt. Kangra/GMS Salwana u/c GSSS Salol Distt. Kangra/GHS Jolna Distt. Chamba but there was no post of TGT(NM) lying vacant. Hence, the petitioner has submitted fresh representation wherein he requested to transfer him at GMS Takhnar u/c GSSS Bhalli District Kangra against vacancy being caused due to promotion of present incumbent.

From perusal of record, it has been found that the petitioner has been working at GSSS Dugli Distt. Chamba since 15.9.2019 and has almost completed three years stay there. One post of TGT(NM) likely to be caused vacant due to the promotion of present incumbent at GMS Takhnar u/c GSSS Bhalli District Kangra. Keeping in view, the above facts and circumstances, the representation of the petitioner is considered sympathetically and he is hereby transferred without TTA/JT from GSSS Dugli District Chamba to GMS Takhnar u/c GSSS Bhalli District Kangra against vacancy being caused vacant due to promotion of present incumbent. These orders will be implemented after the relieving of the present incumbent on promotion and after the completion of three years stay of the petitioner. The representation of the petitioner is disposed of accordingly.

ORDER

In the matter :

CWP No. 5510/2022 titled as Smt. Kirna Kumari,TGT(Med)  
Vs State of H.P. & others.

The Petitioner Smt. Kirna Kumari,TGT(Med) filed CWP No. 5510/2022 titled as Kirna Kumari,TGT (Med),versus State of H.P.before the Hon'ble High Court of H.P. regarding her transfer from GSSS Thachi (MND) (whichs fall under hard /Tribal area) to her choice of station after the completion of required tenure as per policy.The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 26<sup>th</sup> August,2022, when after hearing the matter,the Hon'ble High Court has disposed of the same with the following directions/ order:-

*“ In the given facts and circumstances of the case ,we permit the petitioner ti file a fresh representation clearly setting out therein five station s of her choice out of which on essentially should be outside her home district.In the event of such representation being made within a period of one week,the respondents shall consider ,decide and thereafter issue consequential orders of her transfer within a period of next three weeks.*

*The writ petition stands disposed of in the aforesaid terms ,soalso the pending application,if any.”*

As per direction of the Hon'ble High Court the petitioner was called for personal hearing on dated 14<sup>th</sup> Sep.2022.The petitioner attended the personal hearing on scheduled date and time. During personal hearing the petitioner has requested that she may be adjusted at GHS Churodh (Sundernagar)/GHS Baila(Newly upgraded school) and G(G)SSS Sundernagar Distt. Mandi .

From the perusal of the record, it reveals that Smt. Kirna Kumari, TGT(Med),has been working in GSSS Thachi Distt. Mandi (which falls under hard/Tribal area),since 06<sup>th</sup> May,2017 and has completed her normal tenure at present place of posting. Hence, the representation of the petitioner is considered sympathetically and she is hereby transferred from GSSS Thachi Distt. Mandi to GHS Churodh (S/nagar) Distt. Mandi.These orders will be effective when school is made functional. With these observations, the representation of the petitioner is considered and disposed of accordingly .
