ORDER

In the matter of:

CWP No. 5598/2022 titled as Moti Ram Vs. State
of H.P. & Others.

Whereas, Sh. Moti Ram, TGT (NM) preferred CWP No. 5598/2022 titled as Moti Ram Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GHS Chauras u/c GSSS Ghanduri District Sirmour (hard/sub-cadre area) to the station of his choice. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 18.08.2022 when the Hon'ble High Court has passed the following orders:-

" 2. In the circumstances, we dispose of the writ petition by directing respondent No. 2-The Director, Elementary Education, Himachal Pradesh, to decide the representation of the petitioner expeditiously and in any event within four weeks from today.

3. The petition to stand disposed of in the aforesaid terms, so also pending miscellaneous application(s), if any."

Whereas, petitioner submitted his representation to this office on 23.08.2022 vide which he has requested to adjust/transfer him in the station of his choice i.e. GSSS Daloh/GSSS Lohara/GMS Mather u/c GSSS Saloi /GSSS Mubarikpur/ GSSS Kalruhi/GMS Amb u/c GSSS Amb/GSSS Saleti Distt. Una against vacancy being caused due to promotion of present incumbent.

From perusal of record, it has been found that the petitioner has been working at GHS Chauras u/c GSSS Ghanduri Distt. Sirmour in hard/sub-cadre area since 12.3.2019 and has completed three years stay there. Keeping in view, the above facts and circumstances, the representation of the petitioner is considered sympathetically and he is hereby transferred without TTA/JT from GHS Chauras u/c GSSS Ghanduri District Sirmour to GSSS Daloh District Una against vacancy being caused vacant due to promotion of present incumbent. These orders will be implemented after the relieving of the present incumbent on promotion and after the completion of three years stay of the petitioner. The representation of the petitioner is disposed of accordingly.
